Audit Findings

Audit Narrative

The Virginia Department of Corrections (VADOC) contracted with TrueCore Behavioral Solutions, LLC for the provision of a PREA Audit at Virginia Correctional Center for Women (VCCW), located in Goochland, VA. DOJ Certified auditor Bobbi Pohlman-Rodgers, TrueCore Behavioral Solutions Senior Director of JJDPA/PREA Compliance, was the identified auditor for this facility. The on-site audit was scheduled for March 12-14, 2018. The facility's last PREA audit was on December 17, 2014.

On December 27, 2017, the facility was provided PREA audit notices to be posted where both staff and offenders could view the information. These were sent to the facility and were required to be posted no later than January 30, 2018, which was six (6) weeks prior to the on-site audit. Additionally, the e-mail included the Pre-Audit Questionnaire and the Audit Checklist along with the date that the information was to be to the auditor. The auditor received the Pre-Audit Questionnaire and required supporting documentation on February 13, 2018, four (4) weeks prior to the audit as required.

The auditor reviewed the Pre-Audit Questionnaire and supporting documentation prior to the audit and communicated with the facility on a few items that required clarification or additional documentation. Additionally, the auditor provided to the facility on February 27, 2018 an additional list of items to have prepared for the first day of the audit that included: List of all offenders by housing unit, List of any youthful offenders, List of offenders who have a physical disability, List of offenders who have a hearing disability or who are blind or have limited sight, List of offenders who are limited English proficient, List of Offenders who have a cognitive disability, List of offenders who identify as lesbian, gay, or bisexual, List of offenders who identify as transgender or intersex, List of offenders who have been placed in segregated/restricted housing for being at high risk of sexual victimization, List of offenders who have reported sexual abuse, List of offenders who reported a sexual victimization during the risk screening, List of correctional staff who will be working – by shift, on the day(s) of the audit, Identity of staff who conducts intake, Identity of staff who conducts comprehensive PREA education with offenders, Identity of staff who conduct the risk assessment, Identity of staff who provides medical services, Identity of staff who provides mental health services, Identity of staff on the Incident Review Committee, List of staff who are trained PREA investigators, the Intake/Orientation schedule, Inmate orientation/PREA information that offenders received on intake, and Facility specific information about the services and programs offered at the facility.

The auditor worked with the facility and the Regional PREA Analyst to create a schedule that would allow for the audit to move smoothly. The schedule was set for two (2) days – from 8:00 AM until 7:30 PM each day – with a contingency plan for a third day if needed. During the on-site audit, the schedule was adjusted as needed to accommodate staff schedules and offender schedules. This audit did go into a third day.

The on-site audit began at 8:00 AM on March 13, 2018. Present at the Entrance Meeting were: Warden Wilmouth, Assistant Warden Hill, Chief of Security Scruggs, Chief of Housing and Programs Clark, Operations Manager Nuss, Business Manager Kelly, Food Service Director Reilly, QMHPS Reed, three Unit Managers, and Records Manager. Additionally, the Agency PREA/ADA Coordinator Durbin and Central Regional PREA Analyst Allotey were present. The auditor introduced herself and reviewed the PREA audit process, including timeframes for reports and corrective actions.

The auditor reviewed all documents requested to be available on the first day of the audit. In conjunction with the staff, the auditor selected both offenders and staff to be interviewed. The following is a breakdown of interviews.

Twenty (20) Specialized Staff interviewed: On-site Interviews - Warden, PREA Compliance Manager, Agency Contract Administrator, Upper Level Management, Medical, Mental Health, Non-medical staff involved in cross-gender strip or visual searches, Human Resources, Contractor, facility Investigator, SIU Investigator, Intake Staff, Risk Screening Staff, Restricted Housing Staff, Incident Review Staff, Grievance Officer, and Retaliation Monitor. Prior interviews - Agency Director and the Agency PREA/ADA Coordinator; Telephonic Interviews – MCV Medical Center Charge Nurse for SANE/SAFE services.

Twelve (12) Random Staff Interviews were conducted. Staff were selected from the daily schedule and included supervisory and floor staff from multiple shifts.

The offender population was five hundred and seventy-nine (579) on the first day of the audit. As a result, a minimum of thirty (30) offender interviews were required to be interviewed. Thirty (30) offenders were selected for interview. One offender chose not to participate and an alternative offender was chosen. Thirty (30) Inmate interviews were conducted. Of the Targeted Population Interviews – there was not fifteen (15) offenders who met the identified categories as targeted offenders. Eleven (11) Targeted Inmates included: two (2) offenders with a cognitive disability, two (2) offenders who identified as Lesbian, Gay or Bisexual, two (2) offenders who identified as Transgender or Intersex, three (3) offenders who reported sexual abuse, and two (2) offenders who reported sexual victimization during the risk screening. The facility does not house youthful offenders. Currently there are no inmates with physical disabilities, who are blind, deaf or hard of hearing, who are Limited English Proficient, or who were place in Restricted Housing for High Risk of Sexual Victimization. One (1) offender who contacted the auditor by mail was interviewed. Eighteen (18) additional Random Offenders interviews were conducted. These offenders were selected randomly by the auditor through the use of the housing unit lists, and included at least one offender from each housing unit.

A tour of the facility followed the selection of interviewees. The tour took approximately six (6) hours to complete over the course of the on-site audit. Due to the size of the property, the facility provides supervision of offenders through frequent rounds and positioning. There were no significant concerns regarding blind areas. One window of an office was covered and the covering was removed immediately. There are thirty (30) buildings located on the facility grounds that include.

- Administration and Store Room.
- Chapel
- Gymnasium
- DCE School
- Central Kitchen
- Water Treatment Plan
- Electrical/Paint Shops
- Garage
- Laundry
- Power Plant
- Unit 1-6
- Farm
- Various buildings that are closed and no longer used.

Each building and housing unit was toured. The auditor confirmed that there is information on how to report a PREA allegation and how to access outside Emotional Support for offender viewing. The auditor confirmed that a phone is available in each unit to allow offenders the ability to report PREA allegations. The auditor did confirm that the phones are in working order and offer the ability to report PREA allegations or request emotional support services without cost to the offender and can be used without identification to allow for anonymous reporting. The auditor confirmed that each unit provided toilets, showers, and changing areas that offer privacy from cross-gender staff. The auditor confirmed that there is a grievance box located in a central location where offenders may deposit written communication to administration. The auditor noted that the Notice of PREA Audit was posted in multiple locations throughout the facility where both offenders and staff could view. There was one (1) communication received from an offender.

Day 1: Arrived at 07:45 for Entrance, Tour and Interviews. Departed at 19:45

Day 2: Arrived at 07:45. Interviews. Departed at 20:00

Day 3: Arrived at 07:50. Tour, review of remaining documents, and exit. Departed at 15:00

The auditor conducted an Exit Conference on March 15, 2018 with the following persons in attendance: Chief of Security Scruggs, Chief of Housing and Programs Clark, Operations Manager Nuss, QMHPS Reed, four (4) Unit Managers, Health Authority Smith, RMCA Packett, and Investigator Trent. Additionally, the Agency PREA/ADA Coordinator Durbin and Central Regional PREA Analyst Allotey were present. The auditor discussed minor issues with the following standards: 115.15, 115.17, 115.33, 115.34, 115.35, 115.53, 115.67, and 115.86. The auditor discussed each standard detailing the auditor concerns, which in many cases would strengthen the facility's current system. All were minor and would require little time to implement change and could be conducted within thirty (30) days. A personal "Thank You" was added to this exit as the facility staff work hard to ensure the safety of the offenders in their care and ensured that the audit ran smoothly.

On April 3, 2018 the Regional PREA Analyst provided to the auditor proof of correction for the eight (8) standards. The facility updated necessary documents and provided re-training to staff and inmates as identified by the auditor. At this time there are no further issues with this facility meeting the standards.

Facility Characteristics

Virginia Correctional Center for Women (VCCW) is a Security 2 prison located in Goochland, Virginia. It houses approximately 590 female offenders. VCCW is situated on two hundred and sixty (260) acres of land and contains thirty (30) structures. Offenders are housed in five general population buildings, and there is an additional unit used to house the restrictive unit.

The VCCW opened in 1931 with its oldest building and additional buildings were added beginning 1952. The thirty (30) structures on the institutional property include five (5) general housing buildings, one (1) restrictive housing building, food service kitchen/mess hall, gymnasium, DOE school, administration building, laundry, water treatment plant, power plant, chapel and staff housing. The majority of the buildings are two story brick constructions. Each housing unit has a dayroom with recreation tables. The restrictive housing building has two (2) wings. The facility has a twenty-four (24) hour medical unit, dental clinic and mental health department located in building 2. The total square footage of the five (5) living units and one (1) restrictive housing building is 88,300 square feet. The buildings are spread throughout the hilly acreage looking like a college campus with attractive landscaping. VCCW is unique in that it does not have a perimeter fence or towers. An armed vehicle patrols the property twenty-four (24) hours per day, seven (7) days per week.

VCCW has a capacity of 590 offenders. The average number of inmates is five hundred and twenty-two (522) based on information provided from December 2016 – December 2017. The last Post Audit was May 3, 2017 and this shows there are one hundred and fifty-five (155) Full Time Employee positions. There are 90 authorized BFOQ posts. The last staffing review on January 27, 2017 indicates that while they are currently down some positions, they are maintaining the PREA staffing. A request for additional cameras was included in the review. This review includes that supervisory staff are being used to fill positions, most particularly due to mandated training.

There are five (5) Housing units and one (1) Restrictive Housing Unit at VCCW. Housing units provide ample room for daily living and sleeping areas. During the tour, the staff leading the tour ensured that announcements were made that a male was present in the area.

Unit 1 is general population offenders. Within the building are two (2) units. Both offer day rooms. Offenders are assigned to a double room. There is a general bathroom provided that offers 4 toilets, 5 showers, and 5 sinks. Curtains provide privacy for the toilets and showers. There are four (4) phones on each unit for offender use. Information on the upcoming PREA Audit and How to Report Allegations of Sexual Abuse or Sexual Harassment are posted.

Unit 2 is currently undergoing renovations and is not used for housing offenders at this time.

Unit 3 is general population offenders and special housing. Within the building are two (2) units. The general population unit offers double room occupancy. These rooms contain a sink and toilet. Showers are general use and offer privacy through curtains. There are three (3) phones available in the hallway for offender use. Information on the upcoming PREA Audit and How to Report Allegations of Sexual Abuse or Sexual Harassment are posted. The special housing unit is Restricted Housing. This unit offers single cell occupancy with sink and toilet with in the cell. Showers are general use and offer privacy through curtains. There is one (1) phone available for use upon request. Information on the upcoming PREA Audit and How to Report Allegations of Sexual Abuse or Sexual Harassment are posted.

Unit 4 is general population. Within the building are two (2) units. Both offer day rooms. Offenders are assigned to a double room. There is a general bathroom provided that offers 4 toilets, 5 showers, and 5 sinks. Curtains provide privacy for the toilets and showers. There are four (4) phones on each unit for offender use. Information on the upcoming PREA Audit and How to Report Allegations of Sexual Abuse or Sexual Harassment are posted.

Unit 5 is Cognitive Re-Entry Community population. Within the building are two (2) units. Both offer day rooms. Offenders are assigned to a double room. There is a general bathroom provided that offers 4 toilets, 5 showers, and 6 sinks. Curtains provide privacy for the toilets and showers. There are four (4) phones on each unit for offender use. Information on the upcoming PREA Audit and How to Report Allegations of Sexual Abuse or Sexual Harassment are posted.

Unit 6 is Cognitive Therapeutic Community. Within the building are three (3) units. Both offer day rooms. Housing is open bay. There is a general bathroom provided that offers 4 toilets, 5 showers, and 4 sinks. Curtains provide privacy for the toilets and showers. There are four (4) phones on each unit for offender use. Information on the upcoming PREA Audit and How to Report Allegations of Sexual Abuse or Sexual Harassment are posted.

A gymnasium offers space for recreation and visitation. Recreation is utilized at VCCW to reduce negative activities within the institution and promote the development of personal skills such as teamwork, problem solving and character building. For offenders in the Restricted Housing Unit, they have a designed fenced-in area outside of their building. All other may use the gymnasium or ball field for outdoor exercise. Outdoor

exercise includes walking and intermural sports such as softball and volleyball. Leisure activities are available on each living unit and included board games, reading, television viewing, and movies via videotapes.

Education is offered at the institution. There are three (3) classrooms, General Education Diploma (GED) room, Principal Office. The Library and Cosmetology is located in the basement.

Medical services are available 24/7. Currently located in the basement of Unit 4 while their building is being renovated, all offenders are provided medical care as necessary. Dental services are also available on-site.

The Administrative building offers room for the Warden's office, conference room, financial department and Human Resources.

Treatment offices and therapy rooms are located in the basement of Unit 1. In addition to individual treatment for offenders, the treatment programming at VCCW includes:

Along with the vast array of treatment programming for offenders in general population, VCCW offers an intensive 140 bed Substance Cognitive Therapeutic Community. The mission of the Therapeutic Community is to improve the safe, secure, and cost-effective operation of prisons while providing offenders with an opportunity for positive change. This program is designed as well as structured to create an environment that provides a residential, 24/7, intensive learning experience in which offenders' behavior, attitudes, values and emotions are continually monitored, corrected, or reinforced as a part of the daily regimen. The goal is to re-socialize offenders according to positive values and substance-free lifestyles.

At VCCW, there is an extensive 6-week Pre-Release program called the Cognitive Re-Entry Community. This mandatory program is a means to enhance transitional services for all offenders that are not accepted into the Therapeutic Community. Upon completion of the program, offenders will have obtained valuable transitional services and resource information specific to their needs. The program's goal is to provide female offenders an opportunity to acquire the life skills and resources needed to be successful and health individuals upon their release. The cognitive programming teaches the importance of thinking before reacting, thereby allowing for better decision making. Participants benefit from understanding what is needed to become productive law-abiding citizens, and decreasing their chances to recidivate. Participants also build confidence in themselves by receiving and giving encouragement and respect for others and for themselves. The curriculum includes

Parole and Probation Procedures, Health, Legal Issues, Employment, Finances, Family Relations, Community Resources & Technology, and Personal Growth.

Work and Vocational opportunities are provided to offenders at VCCW.

Jobs are provided to offenders to learn job skills, and to develop good work habits and attitudes that they can apply to jobs after they are released. The VCCW provides a variety of work assignment that meet the institution's need for its food service, housekeeping, maintenance and other operations. Before applying for a job, all offenders are medically cleared. Offenders may apply for a variety of institutional positions or may apply for incentive jobs that are available through Virginia Correctional Enterprises. Employability includes need, offender security level, skill level, disciplinary history, and education/vocational level.

The Food Service Department provides self-operated dining services at VCCW. Its mission is to provide cost-effective, nutritious meals of offenders and staff in a sanitary, safe, and secure environment. The Food Service Department serves approximately 1,500 offender meals and 50 staff meals each day. These meals are based upon a 28-day cycle menu that is prepared by the DOC Dietician and is reviewed and rotated semi-annually. There is one dining hall of approximately 2,000 square feet for offenders and a second 2,000 square foot dining hall that services the offender population in the morning and staff in the afternoon. Additionally, there is a staff dining room for our unique Commercial Foods program. In addition to the Director, Assistant Director and five Kitchen Managers who supervise offenders, there are approximately thirty-six (36) offenders currently assigned to work in Food Service. These offenders include skilled positions as Bakers, Office Clerks, Staff, Diet, Common Fare and Prep and Population cooks, Staff Salad Bar Prep, Cleaners and Storeroom Workers

The Virginia Department of Corrections Commercial Foods program prepares offenders for employment in the food services industry, including nationally recognized ServSafe® certification. The work readiness curriculum includes workplace professionalism, work ethics, communications and financial management. Offenders receive instruction in food preparation, safe food handling, storage and serving of food, customer services, and workplace safety. The program requires approximately eight (8) months to complete. Offenders must be able to read on an eighth grade level and possess fifth grade level math skills. Upon completion of the program, offenders receive certification from the Commonwealth of Virginia. Offenders may also receive college credits through Southside Virginia Community College's concurrent program.

The Commercial Foods Apprenticeship Program is offered to graduates of our Commercial Foods program as well as to Cooks and Bakers from the Central Kitchen. The program requires 4,000 hours of hands-on practice and formal education. Upon completion, graduates receive a certificate from the Department of Labor and Industry.

Cosmetology courses are available. Offenders attend class each day and offenders who complete the program are provided an opportunity to become licensed. The State Board of Licensing tests annually. The services are open to offenders on Tuesday, Wednesday and Thursday. The services are open to staff on Wednesday.

The Virginia Department of Corrections Enterprises Laundry at VCCW provides laundry and linen services with a large number of customers statewide. The current customers range from the Governor of Virginia's linens to hospital and medical facilities. Services include pick-up of the customer's soiled linens and return of the clean linens. The laundry is a commercial-type volume laundry operation that provides quality linen services and is OSHA compliant in infection control procedures. The laundry

maintains a high standard of productive offender work within a real-work worksite environment. The VCCW Laundry employs approximately 100 offender workers daily on two-shifts as a self-supportive Virginia Correctional Enterprises operation. The mission is to reduce offender recidivism by providing job training, instilling transferable job skills and a positive work ethic.

The Horticulture Program at VCCW is a part of the Division of Education. A 6,000 square foot greenhouse and extensive landscaping on the prison grounds provide ample opportunities for the offenders to obtain a certificate in up to seven (7) Department of Labor job titles in the fields of Greenhouse and Nursery management, Landscape Design, Installation, Maintenance, and Floral Design. The class can last up to fifteen (15) months and offers a minimum of sixteen (16) seats per year. The highlight of the year is the Kates Day Plant Sale, sponsored by the Elizabeth Kates Foundation. The Foundation provides seed money which is used to grow plants to earn money for their foundation that funds the purchase of books, college tuition, and other services for offenders. Students also receive training for obtaining other industry certifications while enrolled in the horticulture Program.

The Elizabeth Kates Foundation was founded to honor Elizabeth Kates, the first warden of the VCCW. It is a non-profit organization assisting the VCCW with the Governor's re-entry initiative and helps to increase the odds for brighter future for offenders. Education is the main priority for the foundation, which has provided scholarships, books, and supplies to numerous "Kates Scholars". Through their ongoing efforts, they also coordinate collections for Kates Kiosk, which is a very successful endeavor to provide needy offenders with proper attire as they re-enter society. The Elizabeth Kates Foundation is an excellent partner and their support makes so many opportunities available to the offender population at VCCW. The first Wednesday of May, the VCCW opens its doors to the community for "Kates Day". Guided tours of the facility are offered, and visitors may purchase offender-made crafts and baked goods. Plants which have been grown by the offenders on-site are also available for purchase. The day ends with dinner, performances, speakers and a raffle. All proceeds are used by the Elizabeth Kates Foundation to benefit offenders.

Stevie Trent serves as the VCCW Facility PREA Compliance Manager (PCM). He reports directly to the Warden. In addition to his assigned job as the PCM, he is also an investigator and in charge of Gang Information. He has been with the Agency for 21 years. Of this he has been at VCCW for 10 years and has served as the PCM for approximately 4 years. He coordinates the facility's efforts towards compliance with PREA standards through briefings and electronic mail with staff, as well as frequent contact with the Regional PREA Analyst. When addressing an issue with compliance, he utilizes training, procedures changes and disciplinary action, as well as communicates with the Warden and Regional PREA Analyst.

Rose Durbin is the Agency-wide PREA/ADA Coordinator. She has the responsibility for forty-one (41) Facility PREA Compliance Managers. She has the assistance of three (3) Regional PREA Analysts and a PREA Hotline Coordinator. She reports directly to the Corrections Operations Administrator. Under the direction of the Corrections Operations Administrator, Ms. Durbin manages the activities of the Prison Rape Elimination Act (PREA) and American with Disabilities Act (ADA) Unit of the Department of Corrections. This supervision includes three (3) Regional PREA Analysts and a PREA Hotline coordinator. This position serves as supervisor of the PREA/ADA Unit. Support of assigned unit includes personnel management and support and management of activates in support of all operations objectives. This position has overall responsibility for developing, implementing, and overseeing the Department's program to comply with PREA and ADA initiatives.

Joseph Allotey is the Regional PREA Analyst for VCCW. He is responsible for coordinating the facilities/regions comprehensive PREA response including technical and administrative guidance, creation of supporting policies and practices, design and modification of training, programming, investigation and analysis and interpretation relative to PREA implementation, compliance and investigation. He crafts and orchestrates strategies to ensure appropriate environments/cultures, and enforcement of policies, procedures, practices and standards for the prevention, detention and reduction of prison rape; ensuring proper reporting, trend evaluation and provision of recommendations for improvement and compliance.

VCCW does not contract directly with any outside entity for the confinement of its offenders; however VADOC contracts with GEO Group, Inc. for the running of Lawrenceville Correctional Center. The last contract amendment was in February 2017. The amendment in 2013 added a requirement for the contracted agency to adapt and comply with PREA standards, as well as requires the state agency to monitor for PREA Compliance.

In an interview with VADOC Contracts staff, it was reported that they have one contracted facility for offender

confinement, that the contract requires adaptation and compliance with PREA standards and monitoring by the VADOC staff, that quarterly visits to the facility are conducted by the Regional PREA Analyst, and the VADOC has a staff on-site (former DOC Warden) daily at the facility to address any issues.

SECURITY STAFFING, Operating Procedures 401.2 (rev 2017): Requires each facility must develop and document a staffing plan that addresses all 11 categories as identified in the PREA standard. The facility must also make its best efforts to comply on a regular basis with the staffing plan to provide adequate levels of staffing, and where applicable, video monitoring, to protect offenders against sexual abuse. The last Post Audit was May 5, 2017 and this shows there are one hundred and fifty-five (155) Full Time Employee positions. There are 90 authorized BFOQ posts. The prior review on January 27, 2017 indicates that while they are currently down some positions, they are maintaining the PREA staffing. A request for

additional cameras was included in the review. This review includes that supervisory staff are being used to fill positions, most particularly due to mandated training.

The Post Audit is created at the Agency level and the facility can identify positions and request additional staff. The Post Audit includes the following supervisory positions: one (1) Major, one (1) Captain/Lieutenant, one (1) Lieutenant/Sergeants, one (1) Lieutenant, and ten (10) Sergeants. A review of the Post Audit was conducted by the Warden on February 9, 2017 and reviewed by the Agency PREA/ADA Coordinator on May 5, 2017. Deviations of the Post Audit are documented on the Daily Duty Roster and are identified by code and include: Annual Leave, Comp Time, Civil Work Related, Educational Leave, Family/Personal Leave, Military Leave, Public Health Emergency Leave, Recognition leave, School Assistance & Volunteer Services Leave, Sick Family Leave, Sick Personal Leave, Short Term Disability Leave, Training, Workers Compensation Leave, and Leave without Pay.

The Warden reports that the Post Audit has adequate staffing levels to protect inmates that includes video monitoring. He is responsible to conduct an annual review of the Post Audit that includes addressing generally accepted correctional practices, judicial, federal and oversight body findings, components of the facility's physical plan, composition of the inmate population, number and placement of supervisory staff, programming schedules, state and local laws/regulations/standards, incidents of allegations of sexual abuse, and other relevant factors that may impact the Post Audit. He addresses the number of posts, supported services, camera, physical plant, security level, population, training, and relief factors. He conducts daily reviews of the Daily Duty Roster for deviations of the Post Audit, as well as making regular rounds and unannounced rounds and talking with staff. It is noted that deviations of the Post Audit are handled through involuntary overtime, voluntary overtime, or closing of "non-essential" posts.

Each housing unit contains an ADO Logbook, where unannounced rounds are documented, including the signature of the person conducting the rounds, the date and time. A review of samples provided by the facility of random dates and random housing unit's shows that there is a minimum of one (1) unannounced round monthly by upper or middle management staff; however the majority show unannounced rounds conducted weekly. Staff confirm that rounds are conducted hourly in all areas of the facility in addition to the unannounced rounds and restricted housing conducts 30 minutes rounds. Staff conducting unannounced rounds stated that the ADO is the responsible person for conducting the formal unannounced rounds. Areas visited include housing units, meat plant, school, gymnasium/visitation, laundry and kitchen. She reported that she looks for staff and offender interactions, isolated areas and staff presence during her tours and that all tours are documented in the ADO logbooks.

One (1) blind areas were identified by the auditor during the tour that was immediately addressed. All other areas where there could be a concern had already been addressed through staff supervision, mirrors, or the anticipation of the installation of the new cameras.

Searches by cross gender staff must be approved prior to the search with notification made to the Administrative Duty Officer and the Regional PREA Analyst, and a completed Internal Incident Report must be submitted. Transgender and intersex offenders expressing a preference regarding the gender of the correctional staff conducting the strip search should request consideration of their preference in writing to the facility Treatment Team for review. Only a medical practitioner may conduct probes of the body cavities of an offender, and this must be authorized by the Facility Unit Head or Administrative Duty Officer and must be documented in a completed Internal Incident Report. Requires that only female staff can conduct a frisk search of female inmates. Male staff may conduct a frisk search of female offenders only where there is an immediate threat to the safe, secure, orderly operation of the facility and there is no other available alternative, approval has been granted by the Shift Commander prior to the search, notification is made to the Administrative Duty Officer and the Regional PREA Analyst and an Internal Incident Report is submitted. Access to regularly available programming or other out of cell opportunities for female offenders shall not be restricted in order to comply with this requirement.

DEVELOPMENT AND MAINTENANCE OF POST ORDERS, Operating Procedure 401.1 (rev 2016): Requires that staff of the opposite gender must announce their presence when entering into an offender housing unit.

SECURITY STAFFING, Operating Procedures 401.2 (rev 2017): Requires that offenders shall be permitted to shower, perform bodily functions, and change clothing without nonmedical staff of the opposite gender viewing their breasts, buttocks, or genitalia, except in exigent circumstances or when such viewing is incident to routine cell checks. Also requires that opposite gender staff shall announce their presence when entering an offender housing unit and must document the announcement in the logbook.

FACILITY PHYSICAL PLANT AND SANITATION, Operating Procedure 801.1 (rev 2015): Requires that facility procedures and practices enable offenders to shower, perform bodily functions, and change clothing without nonmedical staff of the opposite gender viewing their breasts, buttocks, or genitalia, except in exigent circumstances or when such viewing is incidental to routine cell checks.

EMPLOYEE, VISITOR, AND OFFENDER SEARCHES, Operating Procedure 445.1 (rev 2016): Allows for searches of offenders at any time. Requires the Agency to train all staff in how to conduct cross-gender pat-down searches, and searches of transgender and intersex offenders, in a professional and respectful manner, and in the least intrusive manner possible, consistent with security needs. Requires female correctional staff to conduct all frisk searches of transgender and intersex offenders unless exigent circumstances are present and documentable, allowing exceptions to this requirement to be referred to the facility Treatment Team. Prohibits the searching of transgender or intersex offenders for the sole purpose of determining the offender's genital status. If genital status is unknown, it allows for determination through offender conversations, review of medical records, or if necessary, by learning that information as a part of a broader medical examination conducted in private by a medical practitioner.

MEDICAL SCREENING, CLASSIFICATION, AND LEVELS OF CARE, Operating Procedure 720.2 (rev 2015): Requires that if a transgender or intersex offender's genital status is unknown, a physical examination will not be conducted for the sole purpose of determining their genital status. This information may be determined during an interview, by reviewing medical records, or if necessary, by learning this information as part of a broader medical examination conducted in private.

OFFENDER RECEPTION AND CLASSIFICATION, Operating Procedure 810.1 (rev 2017): Requires transgender and intersex inmates to complete a "Strip Search Deviation Request" to order to express their preference regarding the sex of correctional staff conducting their strip search, and referral to the treatment team if the offender's preference indicates a deviation. The Treatment Team, which requires the PREA Compliance Manager, will meet and review all deviation requests. Approved deviations shall be noted in

VACORIS, the PREA Compliance Manager shall maintain a list of those approved deviations, and the Chief of Security will ensure compliance with the deviation on all future strip searches.

The facility does not conduct cross-gender visual body cavity searches or strip searches, except in exigent circumstances, and must be authorized prior to the search. Any visual body cavity search is conducted by medical staff. No staff reported conducting a cross-gender strip or visual cavity search. All cross-gender searches are required to be documented in an Internal Incident Report.

VCCW has ninety (90) designated posts that are gender-specific and are documented in the Implementation Memorandum: Leaving Scheduling – BFOQ Positions – Overtime Drafting. These gender-specific posts were identified due to ensure same gender staff is available for searches and supervision of areas where privacy may is not guaranteed by structural features of the facility either due to design or security reasons.

All announcements for cross-gender entering a housing unit is required to be documented. The facility has a logbook in each housing unit where cross-gender staff document that an announcement was made when they entered the unit. Both staff and offenders report that male staff announce their presence. A review of a sample of the logbooks indicates that announcements are made each time a male enters the unit and not just at the beginning of the shift.

The Virginia Department of Corrections provides search training to all staff through Institutional In-Service Training. Samples provided show that “Searches & Restraints” is a normal part of the in-service training that are required to complete annually. Staff interviews found that while many of the staff are aware of the new system for searching transgender and intersex inmates, the majority were not. As a result of this finding, the facility conducted refresher training for all staff on searching transgender and intersex inmates during briefings each shift for twelve (12) days to ensure all staff received training.

Based on the information discovered in the agency policies, observations, and information obtained through staff and offender interviews, and follow-up by the facility, the auditor has determined the facility meets the requirements of the standard.

PRISON RAPE ELIMINATION ACT (PREA), Operating Procedure 038.3 (rev 2016): Requires that offenders with disabilities and who are Limited English Proficient have an equal opportunity to participate in or benefit from all aspects of the agency's efforts to prevent, detect, and respond to sexual abuse and sexual harassment. Efforts shall include the use of interpreters, written material, or other formats or methods that ensure effective communication with offenders disabilities, including offenders who have intellectual disabilities, limited reading skills, who are blind or have low vision, deaf, or are Limited English Proficient. The policy prohibits the use of offender interpreters, offender readers, or other types of offender assistants except in limited circumstances where an extended delay in obtaining an effective interpreter could compromise the offender's safety, the performance of first-responder duties, or the investigation of the offender's allegations.

The Agency has entered into a contract with Purple Communications, Inc. on October 31, 2016 for services of Sign Language Translation and Video Remote Interpreting Services. This is in effect for one (1) year with renewable options. The Agency has used Purple Communications, Inc. since 2011.

The Agency has entered into a contract with Optimal Phone Interpreters, Inc. on November 13, 2015 for services of language interpretation services. A renewal was issued in November of 2016 for another year. Prior to this, the Agency had a contract with Vernacular Language Services from 2014 –2015.

The Agency PREA Coordinator also holds the position for the Agency ADA Coordinator.

The Agency has created a PREA Brochure for the purposes of educating offenders on Prison Rape Elimination Act, which includes information on suspicious behavior, reporting, prevention strategies, making false claims, sexual misconduct definitions, and retaliation. This Brochure is available in English and Spanish (the most common non-English language in the facility). The Agency has also translated the PREA Brochure into Braille

through the services of their Enterprises division at Fluvanna Correctional Center for Women. This is available upon request of any facility. In an interview with a counselor, she was unaware of the Braille material. The facility conducted refresher training for all counselors when accessing alternative methods of educating offenders. Additionally, a copy of the Braille material was obtained and is now maintained at VCCW. It is noted that the facility has not had an offender with significant sight loss due to the design of the facility and type of programming offered.

Staff who conducts PREA education at intake and during Orientation (comprehensive) reports that PREA education is provided in a manner that ensures offender comprehension. It was reported that all information is read at orientation and intake regarding PREA to ensure comprehension of the material. It was also reported that the video that is shown is in both English and Spanish (the most common languages at the facility). If the offender is limited English proficient, a staff interpreter would assist with the provision of PREA educational material. Additionally, the Officer's Log sheet in the system is updated for each offender and details what information was provided and if alternative methods were used.

In an interview with two (2) offenders who have cognitive disabilities, both reported that information was presented to them in a manner they could understand.

Based on the information discovered in the agency policies, observations, and information obtained through staff and offender interviews, and facility follow-up, the auditor has determined the facility meets the requirements of the standard.

LITIGATION, Operating Procedure 040.1 (rev 2015): Requires an employee charged, or convicted, with a criminal offense either on or off the job or a moving traffic violation that occurs on or off the job or in a state vehicle, shall inform their organizational unit head immediate if received during normal working hours, or the next work day if received during non-working hours. Employees who have been charged or found liable in a civil or disciplinary proceeding to have engaged or attempted to engage in sexual activity by force (overt or implied threat of force, coercion, or if the victim did not consent or was unable to consent) shall inform their organizations unit head immediate if received during normal working hours or the next working day if received during non-working hours. All notifications shall be documented on a Criminal Offense/Moving Traffic Violation Notification. Failure to report or material omissions regarding charges convictions of sexual abuse or sexual harassment in an institutional setting, sexual activity by force or coercion (or if the victim could not or did not consent) in the community, or charged or found liable in a civil or administrative proceeding for sexual activity by force shall be grounds for termination.

STANDARDS OF CONDUCT, Operating Procedure 135.1 (rev 2016): States that material omissions regarding convictions or charges of sexual abuse or sexual harassment in an institutional setting, sexual activity by force or coercion (or if the victim could not or did not consent), civil or administrative adjudication for sexual activity by force shall be grounds for termination.

EMPLOYEE PERFORMANCE MANAGEMENT, Operating Procedure 145.2 (rev 2013): Requires that each employee shall be required annually to complete Section I of the Employee Self-Assessment to document a response to the following questions: Have you ever engaged or attempted to engage in sexual abuse in an institutional setting; for example, prison, jail or juvenile facility? Have you been convicted of engaging or attempting to engage in sexual activity in the community where there was use of force, overt or implied threats of force, or coercion, or if the victim did not consent or was unable to consent or refuse? In an interview with the VCCW Human Resources staff, it was reported that the facility performs criminal background checks, or considers pertinent civil or administrative adjudications for all newly hired employees who may have contact with offenders, all employees who are considered for promotion and every five (5) years. They also conduct the same checks for contractors. It was reported that a database is utilized to ensure background checks are conducted every five (5) years. It was reported that all employees have a duty to disclose any previous misconduct at hire and anytime there is a law enforcement contact. Employment applications and background applications contain the three (3) questions regarding sexual abuse or sexual

activity in an institutional setting, community, or if the staff has been civilly or administratively adjudicated for the same, as well as an annual requirement to disclose at evaluation time. Additionally, the three (3) questions are asked during the interview process. There were seventy-four (74) background screenings conducted for employees, and forty-one (41) background screenings conducted for contractors, in the past twelve (12) months. A review of random staff files found that backgrounds were conducted within the past five (5) years.

Requests from other institutions typically contain salary, dates of employment and position held. Those requests requesting information on any substantiated allegations of sexual abuse or sexual harassment is honored when accompanied by a signed release and confirmation from the Agency.

A review of the database reflects all staff have received a background check within the past five (5) years, and all contractors have received a background check within the past five (5) years.

Based on the information discovered in the agency policies, observations, and information obtained through staff and offender interviews, the auditor has determined the facility exceeds the standard, as such the agency requires all staff to annually answer the three (3) questions regarding sexual abuse or sexual activity in an institutional setting, community, or if the staff has been civilly or administratively adjudicated for the same and the facility has conducted all five (5) year backgrounds with no exceptions.

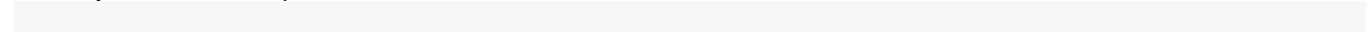

The facility reports both the modification of doors and windows and the installation of additional cameras at the facility. The Schedule of Values and Certificate of Payment reflect that just over \$6,000,000.00 was spent to modify facility windows and doors and install additional cameras.

In an interview with the Warden, he reports that all changes were made with the PREA standards being addressed. They have currently renovated all but two (2) buildings – Unit 2 in progress and Unit 1 pending. Additionally, blind areas were a consideration when determining placement for new cameras.

Based on the information discovered in documents reviewed and staff interviews, the auditor has determine the facility meets the requirements of the standard.

SPECIAL INVESTIGATIONS UNIT, Operating Procedure 030.4 (rev 2015): Identifies that the Special Investigations Unit (SIU) has established a uniform evidence protocol which maximizes the potential for obtaining usable physical evidence for administrative proceedings and criminal prosecutions. The protocol is developmentally appropriate for youth and is based upon or similar to other comprehensive and authoritative protocols developed after 2011. Requires a victim advocate, qualified agency staff member, or qualified community-based organization staff member to accompany and support the victim through the forensic medical examination process and investigatory interview. And requires the victim's consent to collect forensic evidence by a specially trained professional medical practitioner using a kit approved by the appropriate authority (PERK kit recommended). MOU with Virginia Sexual & Domestic Violence Action Alliance went into effect initially in 2015 and has been renewed each year since. The new renewal runs through April 30, 2018. This MOU provides victim advocates as well as emotional support services if requested.

MOU with Blue Ridge Medical Management Corporation (f.k.a. Mountain States Health Alliance) went into effect initially in 2013 and has been renewed each year since. The new renewal runs through August 31, 2018. This MOU provides for PREA Forensic Nurse Examiner Services for five (5) specific facilities throughout the western part of the State.

The facility maintains a rotation schedule for community-based advocates and their contact phone numbers. The schedules provided show services from 2016 through current. The Virginia Forensic Nurse Examiners Program list provides the agency with a list of facilities that conduct SANE services throughout Virginia. The facility reported that SANE and SAFE examinations were available at the Medical College of Virginia (MCV). In an interview with the Charge Nurse at the MCV Hospital, it was reported that SANE services were available. Additionally, the Charge Nurse reported that they would call in on-site Victim Advocates.

In the past 12 months, there have been no allegations where a victim required a forensic medical examination.

The facility reported eighteen (18) allegations of sexual abuse and sexual harassment that were received, of which four (4) received criminal investigations and eighteen (18) received administrative investigations. A review of a sample of seven (7) reports found that investigations were completed as required and investigations began on the day of the allegation. Of the files reviewed, one (1) was verbally reported to staff, three (3) were reported to staff through written communication and both were submitted from an anonymous source, one (1) was reported by another facility, and two (2) were reported through the hotline. All seven (7) files reviewed contained information that the investigation began the same day the allegation was made.

Facility PREA Compliance Manager confirmed that all allegations are taken seriously, and all allegations are investigated. Any internal investigation that identifies criminal activity, or involves a staff member, would be immediately referred to the Special Investigations Unit (SIU). The Special Investigations Unit would work directly with local law enforcement and the Facility Investigator would act in a support position.

Based on the information discovered in the agency policies, observations, and information obtained through staff and offender interviews, the auditor has determined the facility meets the requirements of the standard.

Employees will receive additional training, to include gender diversity, if the employee is reassigned from a facility that houses only male offenders to a facility that houses only female offenders, or vice versa. Employees are required to document that they understand the training and this shall be through employee signature or electronic verification.

TRAINING AND DEVELOPMENT, Operating Procedure 350.2 (rev 2015): Requires annual in-service training requires refresher training on current Department of Correction sexual abuse and sexual harassment policies and procedures and will cover all 10 areas as dictated by PREA standard 115.31. New employee training requires one (1) week of training that includes a three (3) hour PREA class. All ten (10) areas of PREA education as dictated by PREA standard 115.31 were observed in the curriculum. In-service training requires a two (2) hour and forty-five (45) minute PREA class. All ten (10) areas of PREA education as dictated by PREA standard 115.31 were observed in the curriculum. Documents reviewed showed that a formal in-service training was completed annually for the selection of staff interviewed, thus

exceeding the requirement of every two (2) years with refresher in between.

Staff interviews confirmed that they receive PREA education annually through their in-service training. All staff were able to articulate the training that they received. The auditor specifically reviewed twenty-three (23) staff training records and found that all records show training as reported. Material used for training and staff signed rosters were provided to the auditor.

Based on the information discovered in the agency policies, observations, and information obtained through staff and offender interviews, and follow up by the facility, the auditor has determined the facility exceeds the requirements of the standard in that all staff receive formal PREA training annually.

The facility reports three hundred and twenty-two (322) contractors/volunteers who may have access to offenders. Spreadsheets used to track contractors and volunteers show the date of their Orientation training which includes PREA education. Samples of signed PREA Acknowledgement forms were reviewed by the auditor and coincide with the spreadsheet.

The Volunteer Coordinator was present during the on-site audit and was interviewed by the auditor. She reported that she and all volunteers/contractors receive Zero Tolerance Training that covers what it is, how to report, comfort zones, treatment, and respect. She reports that they are to contact staff in area and also report to the Operations Manager. Eleven (11) files were reviewed and all contained the appropriate Acknowledgement form completed by the volunteer/contractor.

TRANSFERRED OFFENDER RECEIVING AND ORIENTATION, Operating Procedures 810.2 (Ref 2016): Requires that inmates transferred from one facility to another will be provided a copy of the Sexual Assault Awareness and Prevention Brochure that includes the Sexual Assault Hotline number. If there is no record of having received the comprehensive PREA education in the offender's record, the offender will then be provided PREA training as described for a new intake. Each facility shall ensure that key information is continuously and readily available or visible to offenders through posters, offender handbooks, or other written formats.

Sexual Assault Awareness and Prevention brochure contains information on What is PREA?, Suspicious Behavior, Reporting, Prevention strategies, Sexual Misconduct definitions, Making False Claims, Retaliation, and 3rd Party reporting information. Methods of reporting within this brochure include telling a staff, utilizing the PREA hotline #55, and contacting the National Sexual Assault Hotline (1-800-656- 4673). Obtaining emotional support services can be requested by calling the Virginia Victim Assistance Network (1-800-838-8238) or writing to the Virginia Sexual & Domestic Violence Action Alliance at PO Box 17115, Richmond, VA 23226. Third party reporting can be made to the Virginia Department of Corrections PREA Office at 1-855-602-7001.

Offender Orientation Manual contains PREA education that is reviewed during the Orientation process. The manual contains specific information on the Prison Rape Elimination Act, PREA Hotline, Strategies to avoid sexual abuse/assault, Agency Zero-Tolerance policy, Other ways to report, Emotional Support Services and how to access, Victim Advocates and how to access, and AIDS information.

Staff who conducts the intake process reports that all new offenders receive PREA information at intake. Upon arrival, the offender process through security, medical, mental health, and eventually meets with intake staff to conduct the intake PREA education. Offenders are provided the PREA brochure, narrative of the information being verbally presented, and information on how to report allegations and how to access emotional support services. Orientation is completed within seven (7) days. Orientation includes a video that is in English and Spanish and contains closed caption capability. Individual meetings are held with offenders as well to ensure understanding of information. Offenders also receive information on how to report allegation and how to access emotional support services. Offenders sign an Acknowledgement of Preventing Sexual Abuse and Sexual Assault. The Acknowledgement Form contains space for offenders to sign off that they have received the appropriate information.

Interviews with offenders confirmed that intake process and orientation are conducted. Offenders stated that they receive information on the first day and then again in orientation. Some offenders, during the interview, stated that they were not aware that family could report on their behalf, but were aware that third party reports were accepted. This was discussed with the facility who updated their Offender Handbook to ensure that this was clearly identified as option for reporting.

A review of offender PREA education forms was conducted. There were forty (40) files presented to the auditor for review. All PREA education was provided within the appropriate time frames as required by the PREA standards. It is noted that the Agency policy is more restrictive than the PREA Standard and with few exceptions all PREA education was completed within the Agency time frame. Additionally, the facility created a system to ensure that all staff who conducts intake and orientation are made aware of new offenders and the date of their arrival to ensure that PREA education is provided as required by the Agency policy.

Based on this review, the auditor discovered that the facility is providing PREA education on the first day of arrival and comprehensive PREA education within ten (10) days but typically within seven (7) days.

Based on the information discovered in the agency policies, observations, and information obtained through staff and offender interviews, the auditor has determined the facility exceeds the requirements of the standard by providing PREA education within ten (10) days of arrival.

SPECIAL INVESTIGATIONS UNIT, Operating Procedure 030.4 (rev 2015): Requires that PREA Investigators shall complete general PREA Training that is provided to all employees and specialized training in conducting sexual abuse investigations in confinement settings. Specialized training must include: Techniques for interviewing sexual abuse victims, Proper use of Miranda and Garrity warnings, Sexual abuse evidence collection in confinement settings, and Criteria and evidence required to substantiate a case for administrative action of prosecution referral. Topics covered include Module 1: PREA Refresher and Overview of the PREA Investigative Standards, Module 2: Legal Issues & Agency Liability, Module 3: Overview of the VA DOC Policies and Procedure, Module 4: Agency Culture and Boundary Issues, Module 5: First Response and Evidence Collection, Module 6: Forensic Medical Exam, Module 7: Trauma and the Victim Response, Module 8: Prosecutorial Collaboration, Module 9: Interviewing Techniques, and Module 10: Report Writing.

The facility has two (2) facility investigators for PREA purposes. The facility provided proof of two (2) facility investigator trainings that were conducted as required. In an interview with an Investigator, the Investigator reported receiving training through the staff development and the Virginia State Police Academy, as well as annual PREA education. He reported that he has received specialized training on interviewing techniques, Miranda warnings, Garrity warnings, sexual abuse evidence collection, and the criteria and evidence required to substantiated a case for administrative or prosecution referral.

The Agency has multiple investigators within the Special Investigations Unit. In an interview with an SIU Investigator it was reported that SIU staff had not all completed the specialized training as required by the standard; however it was completed prior to the writing of this report and the Agency provided specialized training certificates for all SIU investigators.

The facility provided documentation for the annual staff PREA education. Some records for the specialized training were not available and as such the facility ensured that all staff repeated the training and copies of the records were forwarded to the auditor for review. It was noted that during the interview, both medical and mental health staff were able to articulate the requirements of the specialized training.

Interviews with medical and mental health staff confirmed that they have received appropriate training in detecting/assessing for signs of sexual abuse and sexual harassment; preservation of physical evidence of sexual abuse; responding effectively and professionally to victims of sexual abuse and sexual harassment, and how and to whom to report allegations or suspicious of sexual abuse or sexual harassment either through Agency training, NIC training or as required by their licensure. Mental Health staff confirmed that he has been the first person to be made aware of an incident of sexual harassment that was reported approximately three (3) years ago and it was immediately reported.

Based on the information discovered in the agency policies, documentation reviewed, and information obtained through staff interviews, the auditor has determined the facility meets the requirements of the standard.

In an interview with the staff who conducts the risk screening, it was reported that an initial screening is conducted within twenty-four (24) hours of the offender's arrival. As a part of this process, staff review prior information in the agency computer, pre-sentencing reports, health issues and past criminal behavior. The screening that is conducted includes any disabilities, age, physical build, current and previous incarcerations, violent offenses, LGBTI status, mental illness, prior victimization and assaultive behaviors. Additionally, offenders are asked about their perception of vulnerability.

The auditor conducted a review of the thirty (30) printed database information sheets of the offenders that were selected for interview to ensure that the screening is conducted as required by policy. This review showed that with little exception offenders receive a screening within twenty-four (24) hours of arrival. In a memo from the prior Agency PREA Coordinator, dated April 30, 2015, requires that risk screeners must document their own perception of gender non-conforming in the database as a part of the total risk screening. A review of the database found that this information is also present. A review of files found that this is occurring.

Access to information is available only to the Warden, counselors, QMHP's, medical staff, Unit Manager, Major and the Facility PREA Compliance Manager. Additionally, it is noted that lists are available that identify those at risk of victimization and those at risk of being sexually aggressive area generated versus staff reviewing the screening information which allows for specific information to remain confidential. Referrals are made to medical or mental health at the time of the screening and these are documented. A review of documents indicates the facility is compliant with their policies and PREA standards for timeframes.

Per staff interview, risk assessment information is reviewed within fourteen (14) to twenty-one (21) days, if there is an incident of sexual abuse, upon request, or if there is receipt of additional information that bears on the offender's risk of sexual victimization nor abusiveness.

A review of the documentation provided at the facility shows that reviews of the risk assessment occur within thirty (30) days. This review showed that offenders receive a rescreening as required.

Should both an offender who is identified as vulnerable to victimization and an offender who is identified as a sexual aggressor be in the facility, it was reported to the auditor that steps would be taken to ensure they are separated by housing unit, programming, work, and education. This is completed through the generation of a list that identifies those at risk of victimization and those are risk of being sexually aggressive. She also reported that transgender and intersex inmates are reassessed twice per year (January and July), as well as on arrival, within 14-21 days of arrival, and as deemed necessary. The interviewee reported that an offender's perception of risk is addressed and provision will be made on a case-by-case basis for showering changes.

The Facility PREA Compliance Manager also stated that the lists generated that identify offenders who are at risk of victimization or who are identified as sexually aggressive is reviewed for hosing, work, education and to keep offenders safe.

The auditor reviewed the generated list in order to determine targeted interviews. Inmates interviewed who identified as transgender or intersex reported that there were no concerns regarding their placement, that there is not a special unit just for LGBTI offenders, that they were asked about their safety, and they had

requested separate shower times.

File reviews found that the offender who identified as HRSV meet with the QMHP to identify any services that may be needed. Staff are required to complete reassessments every Jan & July for transgender and intersex inmates.

Based on the information discovered in the agency policies, observations, and information obtained through staff and offender interviews, the auditor has determined the facility meets the requirements of the standard.

A memo from the Warden, dated January 3, 2018 states that they have had no offenders identified as high risk of victimization requiring placement in restricted housing in the past year. He did report that a transgender or intersex offender may be placed in restricted housing overnight in order to assess housing, but that it had not occurred.

In an interview with staff who work in restricted housing, he reported that he has been working there for approximately one (1) year and has not seen this occur. He reports that offenders placed here for their own protection would have access to programs, privileges, education and work only if there is no safety concern and that this would be documented. He reported that offenders placed in RHU would be reviewed every 30 days and that this meeting is held with counselors, unit manager, the Major and the Facility PREA Compliance Manager.

No offender interviewed who made an allegation or reported a prior victimization reported being placed in RHU. This was confirmed through the investigation files.

Based on the information discovered in the agency policies, observations, and information obtained through staff and offender interviews, the auditor has determined the facility meets the requirements of the standard.

Notification to staff or written communication is available for reporting sexual abuse or sexual harassment. Offenders are also informed upon intake that they can dial #55 – option 1 – a direct line to reporting abuse following an incident of sexual abuse or sexual harassment, which does not require an offender's personal identification number when calling. This line goes directly to Virginia DOC

PREA/Sexual Abuse Hotline. Offenders are also advised that they can tell any staff member, including contractors or volunteers, who are trained and required to report all allegations of sexual abuse or sexual harassment. Offenders can also report sexual abuse or sexual harassment in writing through the Informal Complaint system or the Formal Grievance system.

Externally, offenders can contact Action Alliance through the use of the #55, option 2, who has entered into a Memorandum of Understanding with Virginia DOC. This MOU provides that Action Alliance will receive calls alleging sexual abuse and sexual harassment and forward this information to the Agency PREA Coordinator and will maintain confidentiality if so requested by the offender. Information regarding reporting through Action Alliance is provided to offenders upon intake. The auditor called Action Alliance utilizing the offender phone system to verify it was working and that services are provided to offenders if requested.

Staff interviewed confirmed that they will accept allegations of sexual abuse or sexual harassment verbally, in writing, anonymously, and from their parties and report to their supervisor. Staff are also provided information for reporting in a confidential manner through a separate phone number that is outside of the facility.

Offender interviews found that they were very familiar with how to report sexual abuse or sexual harassment, that they were provided information on their arrival, and that there is information posted in the facility to remind them of how to report.

The auditor observed a variety of information posted throughout the facility that ensures offenders have information to access reporting sexual abuse or sexual harassment. Additionally, the facility has the PREA/Sexual Abuse Hotline number posted near phones.

A file review of allegations of sexual abuse or sexual harassment in the past twelve (12) months indicates that the Agency and facility have established various methods of reporting, including to an outside entity. The file review showed that one (1) was verbally reported to staff, three (3) were reported to staff through written communication and of which two (2) were submitted from an anonymously, one (1) was reported by another facility, and two (2) were reported through the hotline.

Based on the information discovered in the agency policies, observations, and information obtained through staff and offender interviews, the auditor has determined the facility exceeds the standards, as such the facility offers direct reporting through staff and a dedicated phone line for reporting sexual abuse that allows an offender to remain anonymous.

MOU between VADOC and Virginia Sexual and Domestic Action Alliance, last Contract Extension dated January 23, 2017 for extension of services from May 1, 2017 through April 30, 2017. Original contract was dated May 1, 2013. Action Alliance agrees to provide a statewide hotline shall provide confidential crisis intervention and emotional support services related to sexual abuse or assault for DOC victims each month who are calling the toll-free telephone number. Action Alliance agrees to conduct appropriate background screening on call handlers.

Offenders are able to request confidential support services through their counselor or through Action Alliance, a community service provider under an MOU to provide such services. Offender access to Action Alliance is provided during Orientation. Contact with Action Alliance is through the offender phone system, #55 and option 2. Interviews with offenders found that they were unfamiliar with how to access outside emotional support services or what services were being offered. Prior to the writing of this report, VCCW ensured that appropriate information was included in Orientation and clearly posted in the housing unit.

Based on the information discovered in the agency policies, observations, information obtained through staff and offender interviews, and facility follow-up, the auditor has determined the facility meets the requirements of the standard.

Interviews with staff, including medical and mental health staff, confirm that they are required to report any knowledge, suspicion or information of sexual abuse or sexual harassment to the Facility PREA Compliance Manager, Investigator, or other Administrative staff. Medical and mental health staff report that they provide to offenders the limitation of confidentiality and their duty to report through a mandated form. The Warden and Facility PREA Compliance Manager confirmed that all reports of alleged sexual abuse or sexual harassment, regardless of where the information came from, is reported to the Investigator.

A review of seven (7) allegations found that the investigation began immediately upon receipt of information.

Interviews with staff indicated that they are required to immediately separate an offender who is believed to be at risk of imminent sexual abuse and to contact their supervisor. This was confirmed in interviews with the PREA Compliance Manager. As an example, one (1) file reviewed where the allegation included a staff member, the facility immediately removed the staff member from contact with all offenders.

In the interview with the Agency head, the Special Investigations Unit (SIU) would be notified by both the facility receiving the allegation and the facility where the allegation took place as per policy. The SIU would respond to the facility where the offender is located to conduct an interview. This system would ensure that all allegations are reported.

The facility reported one (1) allegation was received by an offender who reported a sexual abuse in another VADOC facility. This was immediately reported to SIU and to the facility where the event allegedly occurred. This is documented in the investigation file that was reviewed by the auditor.

A Warden's memo, dated January 16, 2018, states no allegations of sexual abuse that occurred in VCCW was received by another facility. The Pre-Audit Questionnaire reports one (1) allegation received from another facility. A review of seven (7) investigation reports indicated that there was one (1) in June 2017 where another VADOC facility reported an offender alleged sexual abuse. The investigation was completed by VCCW investigators and found unsubstantiated. The investigation began upon receipt of the information.

A review of the training material finds that all staff receive information on responding to an allegation of sexual abuse by separating the victim from all others, protecting any physical evidence by requesting that the victim does not destroy evidence (through washing, brushing teeth, changing clothing, urinating, defecating, smoking, drinking or eating), protecting any physical evidence by ensuring the alleged perpetrator does not destroy evidence (through washing, brushing teeth, changing clothing, urinating, defecating, smoking, drinking or eating), and securing the crime scene. Interviews with staff found that they were able to articulate the steps required if they become aware of a sexual abuse. Staff are issued a card to attach to their badge with the same information as a reminder of policy. This same information is noted within the Coordinated Response Plan.

In interviews with staff, all reported that they are required to protect/separate the victim, preserve any forensic evidence (on the offender, perpetrator or in the area where the incident was alleged to have occurred). An interviews with one (1) volunteer confirmed their knowledge and actions to protect the victim and notify the nearest security staff.

The Sexual Assault Response Checklist was provided to the auditor and this form documents initial information related to the response of an incident of sexual abuse, as well as names/phone numbers for appropriate communication of the events.

The Warden reports that the Facility PREA Compliance Manager ensures compliance with the Plan. The Coordinated Response Plan is a step-by-step plan instructions guide on evidence collection, document preparedness and review, and notification of administration, mental health, medical and investigators.

A review of the investigation files for sexual abuse that occurred shows compliance with the facility plan. The hospital had recently changed and the Coordinated Response Plan provided to the auditor did not have updated information. The facility updated the Coordinated Response Plan as a result of the findings and provided the updated plan to the auditor prior to the writing of this report.

The facility provided a memo, dated April 22, 2013, which states "In accordance with the Code of Virginia, collective bargaining is prohibited. This was confirmed with the Agency PREA/ADA Coordinator that collective bargaining is not utilized in VADOC.

The staff who conducts retaliation monitoring is the Facility PREA Compliance Manager. She utilizes a facility specific form to documents thirty (30), sixty (60) and ninety (90) day checks of victims, reporters, and others who express fear of retaliation. This form documents the date of the allegation, the date the investigation was closed, the outcome of the investigation, and the monitoring of disciplinary report, housing changes, program/job changes, and allows a section for comments such as continue monitoring or additional status checks. She reports that all alleged victims or reporters are met with within twenty-four (24) hours and every thirty (30) days thereafter. She monitoring for bed moves, job changes, educational changes, disciplinary actions, and new charges. All retaliation checks are additionally documented in CHORUS.

A review of his logs indicates date of allegation, monitoring, status of offender, any movement of offender, date of transfer if offender was transferred, and areas reviewed that may indicate retaliation.

A review of the logs, information on the Pre-Audit Questionnaire and interview with the PREA Compliance Manager concluded that retaliation has not occurred at the facility in the past twelve (12) months.

Based on the information discovered in the agency policies, documentation reviewed, observations, and information obtained through staff interviews, the auditor has determined the facility meets the requirements of the standard.

Both investigators who were interviewed (facility and SIU) reported that they have received appropriate training. Both reported that all allegations are investigated, regardless of how the information is initially obtained and both reported that investigations begin immediately upon notification. The facility investigator conducts an initial investigation to determine if criminal behavior is involved or a staff person is the alleged perpetrator, at which time the investigation would be sent to SIU. Unless otherwise directed, the facility administrator collects evidence and maintains the evidence as required. Both report that the credibility of the victim is based on evidence found, and that no polygraph examination or truth-telling device is a condition for proceeding with an investigation. Both investigators report that an investigation does not cease until complete, regardless if the alleged perpetrator is released or terminates employment, or if the victim leaves the facility prior to the completion of the investigation. The facility investigator reported that she would play a support role if the investigation was conducted by the SIU.

The auditor reviewed seven (7) investigation files and found evidence of compliance with the VADOC policy and the Investigators interview regarding the investigation, collection of evidence, and retention of documents.

Warden's memo, dated January 31, 2018, states that there were no instances where the licensing body required notification.

A review of the seven (7) investigations was conducted. There were no allegations of sexual abuse or sexual harassment against a volunteer or contractor.

Based on the information discovered in the agency policies, observations, and interviews with staff, the auditor has determined the facility meets the requirements of the standard.

A memo form the Warden, dated January 11, 2018, states that there have been no findings alleging sexual abuse by an offender towards an offender that resulted in disciplinary action. This was confirmed in the Warden's interview.

A review of the seven (7) reports did not find any substantiated outcomes of sexual abuse that resulted in disciplinary action taken towards the alleged perpetrator. Additionally, there were indications of disciplinary action towards an alleged victim when it was determined that the allegation was fabricated.

Based on the information discovered in the agency policies, observations, and staff interviews, the auditor has determined the facility meets the requirements of the standard.

Staff who conducts the risk assessment also confirmed that notification to medical/mental health is made when an inmate reports a prior victimization. Medical and mental health staff were aware of the requirement for informed consent before reporting information about a sexual victimization that did not occur in an institutional setting. The Warden and Facility PREA Compliance Manager confirmed that persons under the age of 18 are not housed at this facility. Documentation of follow-up meetings were reviewed.

Interviews with medical staff and mental health staff confirm that victims of sexual abuse receive timely and unimpeded access to emergency medical treatment and crisis intervention services. Medical confirmed that services begin immediately upon notification and carry through any hospital orders, or medical practitioner follow-up care. If medical staff or mental health staff are not present, the Shift Commander would make appropriate notifications and following directives of medical staff regarding any forensic examination. The facility would follow the Coordinated Response Plan which includes notification to medical and mental health staff, as well as transporting the victim to a local hospital if the incident was reported in a timely manner that allowed for evidence collection.

Medical reported that the hospital would begin any sexually transmitted infection prophylaxis treatment/services and orders would be for follow-up services. Mental health services begin when the victim is available and after medical care is first provided. Mental health staff report that they would see the victim no later than 24 hours of an incident and provide one-on-one counseling and make available outside emotional support services.

In a review of seven (7) investigation reports, the auditor saw documentation of immediate referrals for mental health and medical care, including forms where the alleged victim refused medical care. Referrals for mental health and medical care are made for both sexual abuse and sexual harassment allegations are present in the files, along with mental health and medical documentation of services. Documentation in the files indicates that services are provided immediately upon notification.

There have been no allegations of sexual abuse at this facility during the reporting period where an inmate was transferred out to for a forensic examination. Medical staff confirmed they have not been made aware of any allegations that were reported directly to them.

group treatment, treatment plans, referral to the Psychiatrist, medications as ordered by the physician, laboratory testing for STD and HIV and follow-up. Mental Health staff report a plan for services would include individual or group treatment, including trauma resolution and PTSD, as well as follow-up. The mental health staff reported that mental health evaluations of all known offender-on-offender abusers are offered treatment services within fourteen (14) days, and if a new report, a new mental health evaluation would be completed as quickly as possible. Mental health staff also reported that all offenders receive a mental health evaluation during their few weeks at the facility.

He reports that an Incident Review Team has not been conducted review at this facility since 2016 as there have been no substantiated or unsubstantiated investigations of sexual abuse in the past reporting period.

A review of the seven (7) investigation files found that those identified as sexual abuse closed as unsubstantiated totaled three (3) files. Each file contained a Sexual Abuse Incident Review form that was completed within the required time frame. Each form addresses the required components of the standard. Corrective action, if identified, was completed.

The auditor was provided the 2014, 2015, and 2016 annual reports. The reports reflect comparison data and corrective actions specific to VADOC facility and private facility as well as to the agency. The report was approved by both the Agency PREA Coordinator and the Agency Head.

Interview with the Agency Head found that the agency utilizes Incident Report, Critical Incident Debriefing and an After Action Report to assist with identifying the lessons learned and to obtain information on facility specific corrective action. The Agency PREA Coordinator reports that information is gathered and submitted to the public through an annual report that is available on the website, and includes comparison data and any facility modifications or agency policy changes. She also reports that the information is security retained and ongoing corrective action is tracked. The Facility PREA Compliance Manager reports that all information collected from Incident Review is forwarded to the Regional PREA Analyst.

Based on the information discovered in the agency policies, observations, documents, and information obtained through staff interviews, the auditor has determined the facility meets the requirements of the standard.
