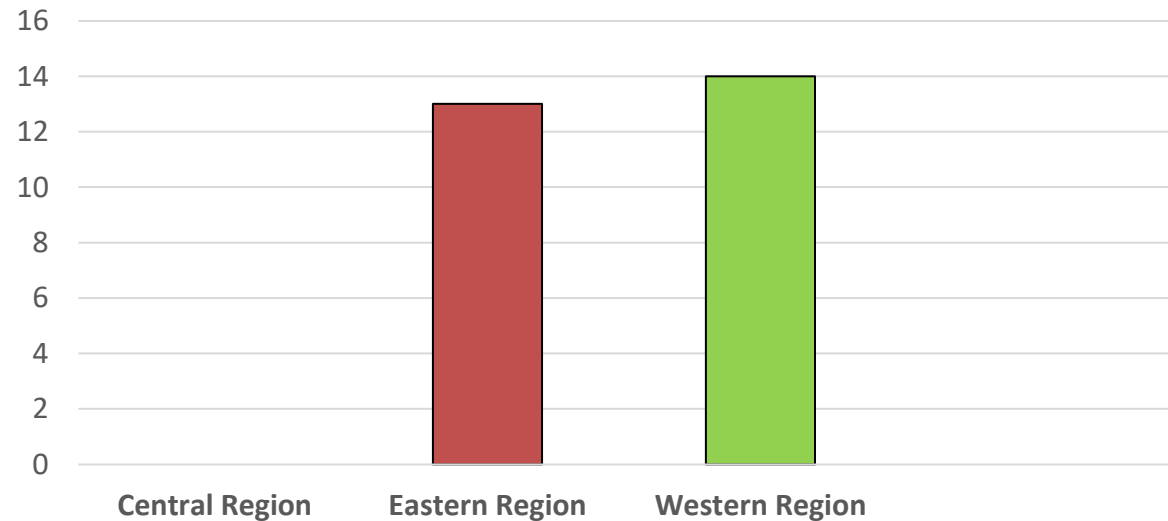

Contact between the penis and vagina or the penis and the anus including penetration, however slight; or contact between the mouth and the penis, vagina or anus; or penetration of the anus or genital opening of another person by a hand, finger, or object.

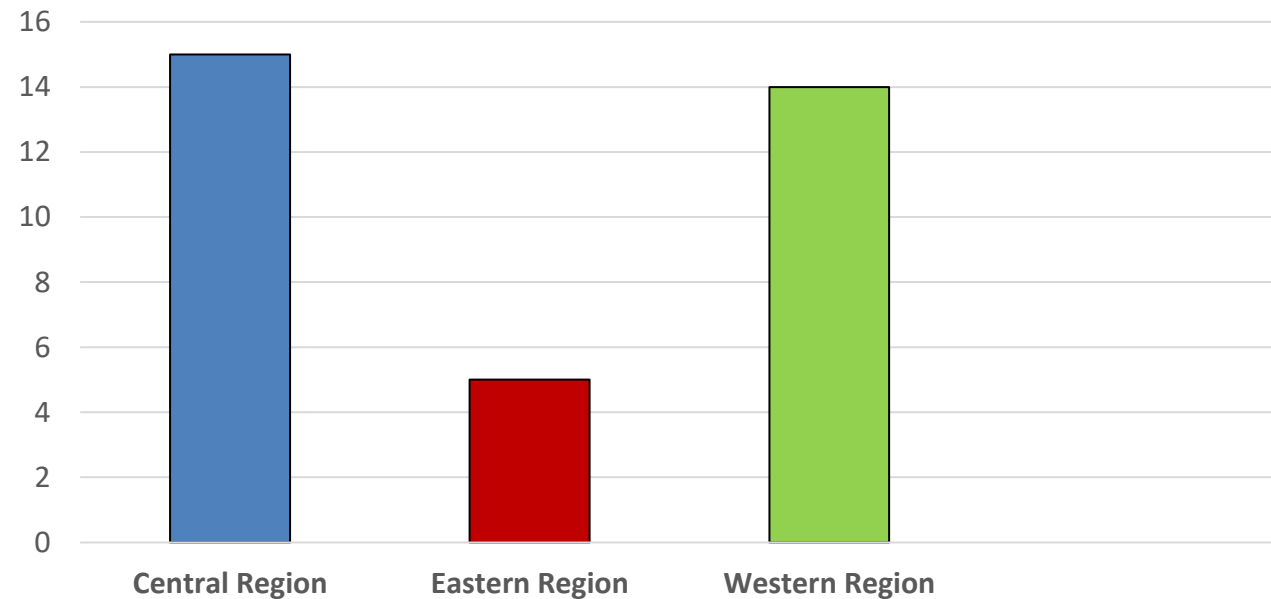

Intentional touching, either directly or through the clothing, of the genitalia, anus, groin, breast, inner thigh or buttocks of any person. Incidents in which the intention is to sexually exploit (rather than harm or debilitate).

- Central Region had 15 claims
- Eastern Region had 5 claims
- Western Region had 14 claims

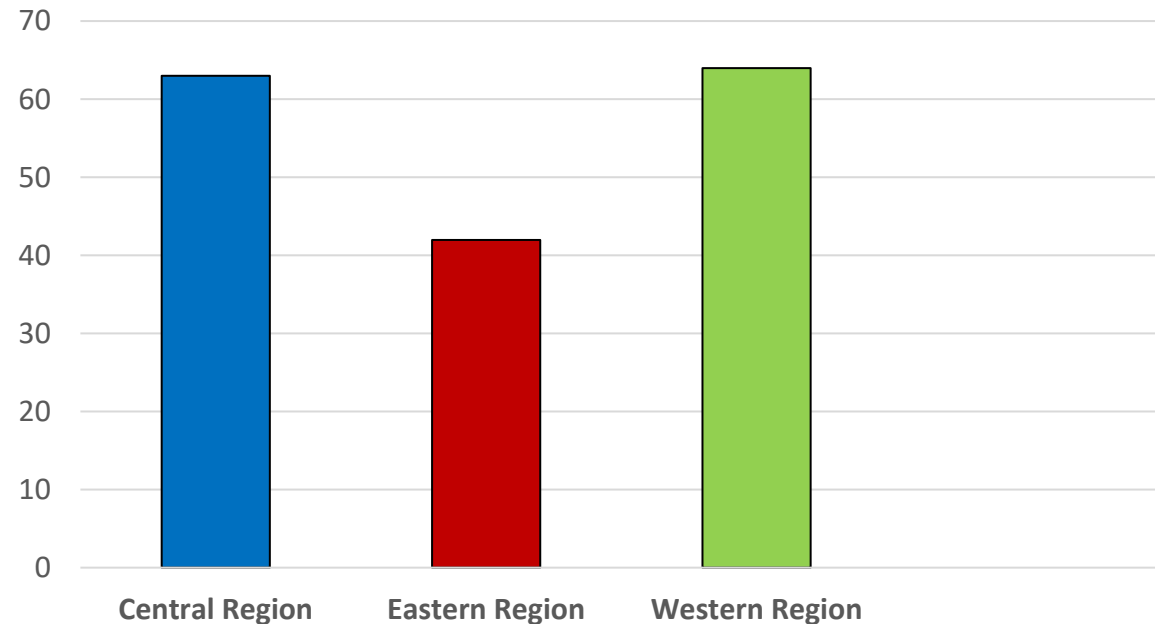

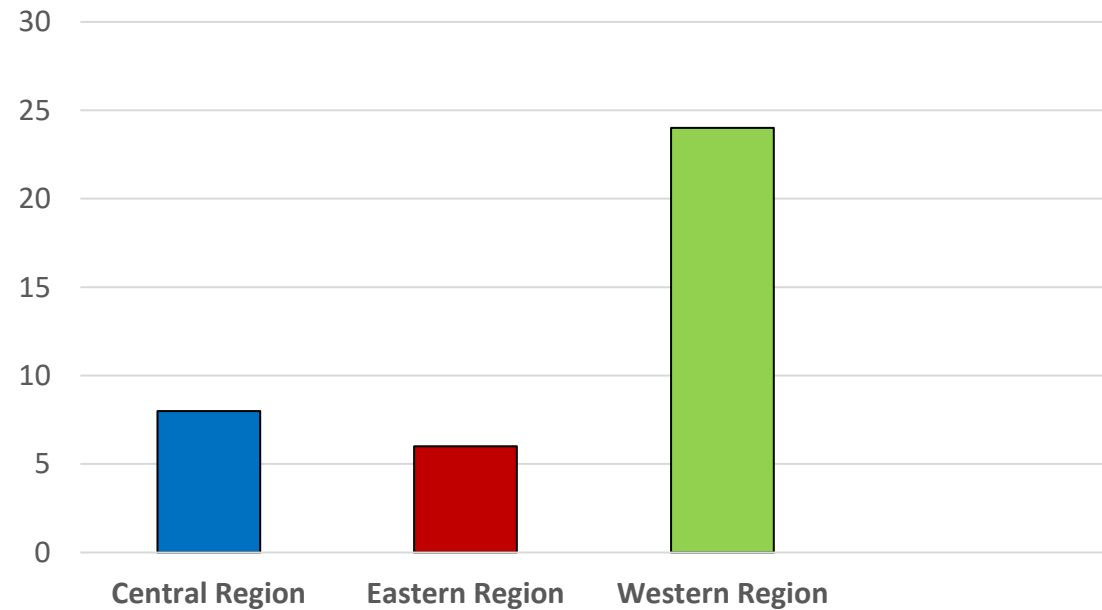

Staff Sexual Misconduct 2022

Any behavior or act of a sexual nature, whether consensual or nonconsensual, directed towards an inmate by an employee, volunteer, official visitor or agency representative. Such acts include: intentional touching of the genitalia, anus, groin, breast, inner thigh or buttocks with the intent to abuse, arouse or gratify sexual desire; or completed, attempted, threatened, or requested sexual acts; or occurrences of indecent exposure, invasion of privacy or staff voyeurism for sexual gratification.

- Central Region had 8 claims
- Eastern Region had 6 claims
- Western Region had 33 claims

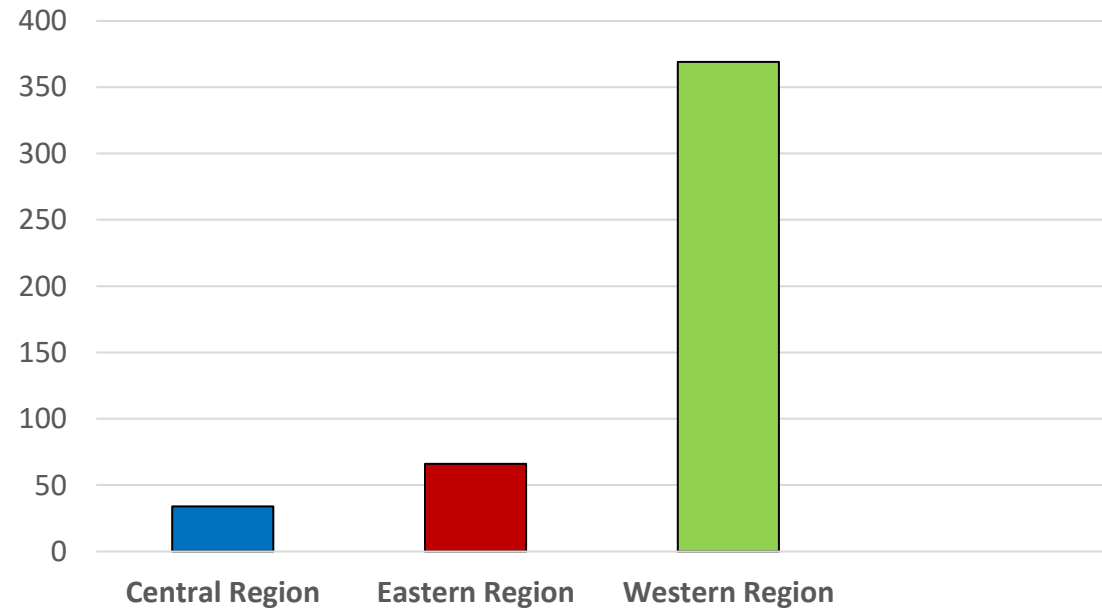

Repeated verbal statements or comments of a sexual nature to an inmate by an employee, volunteer, official visitor or agency representative. Such statements include demeaning references to gender or derogatory comments about body or clothing; or profane or obscene language or gestures.

- Central Region had 34 claims
- Eastern Region had 66 claims
- Western Region had 369 claims

Corrective Actions for 2022 – *Central Region*

Baskerville Correctional Center

- All cameras were upgraded to MaxPro.
- Three additional cameras were added; two in the Medical Department and one at Front Entry.
- Trained, non-security staff were utilized to help relieve security staff for lunch breaks and assisted with visitation on the weekends.

Corrective Actions for 2022 – Central Region

Beaumont Correctional Center

Prior to the facility opening on June 1, 2022, various upgrades were made to bring the facility into compliance:

- Additional perimeter lighting was installed around the entire facility.
- Restroom signs were posted in work areas to clearly identify staff and inmate restroom areas.
- Swinging doors were installed outside toilet and shared shower areas to provide adequate privacy without affecting proper security.
- Dividers were installed between each shower head in the shower area to allow for privacy when in use for multiple inmates at a time.
- New cameras were installed throughout the facility to include housing, work, and program areas. This provides clear views of all areas and eliminated blind spots.
- Strip search areas had privacy dividers installed.
- Priority one posts were maintained through staffing adjustments and overtime.

Corrective Actions for 2022 – Central Region

Buckingham Correctional Center

- In follow-up to a PREA incident review, refresher training was provided to staff on the proper way to handle PREA incidents. The training consisted of policy review and scenario questions.
- With high vacancy rates at the facility, both security and trained non-security staff from other facilities were utilized on security posts. On occasion, inmate movement was modified.
- The facility held inmates found in unauthorized areas accountable by utilizing the disciplinary process.
- Additional cameras for various areas of the facility have been requested in the Staffing Plan.

Corrective Actions for 2022 – Central Region

Central Virginia Correctional Unit #13

- As a follow-up to a recommendation made during a PREA audit, frosted plastic glass was installed at the downstairs inmate bathroom to provide additional privacy.
- To ensure adequate staffing, the facility utilized the draft calendar.

Chesterfield Women's Community Corrections Alternative Program

- No upgrades or corrections were necessary at the facility during this time. However, additional cameras have been requested.
- The requirements of identifying and reporting PREA incidents were covered in all staff meetings.
- To ensure adequate staffing per shift, the facility utilized a draft schedule.

Corrective Actions for 2022 – Central Region

Coffeewood Correctional Center

- Dedicated monitors for viewing MaxPro Camera footage were added in the Warden's office and the Watch office.
- The leadership evaluated areas of the facility where cameras are needed and addressed the camera needs with the VADOC Electronics Unit.

Dillwyn Correctional Center

- Additional facility cameras were installed.
- Staff were retrained on proper strip search and frisk procedures per the mandated policy.
- Lighting was added to the parking lot to increase security.
- To assist with additional privacy for inmates when taking showers, shower dividers have been ordered.

Corrective Actions for 2022 – Central Region

Fluvanna Correctional Center

- To assist with the detection and deterrence of sexual abuse and/or sexual harassment incidents, 74 additional cameras were installed; 56 throughout the facility and 18 in the warehouse.
- Staff were retrained on timely inmate education and classification assessments to ensure compliance.
- To assist with staff shortages, trained non-security staff and OIT's performed limited security assignments. Staff assistance was also received from other facilities.

Halifax Correctional Unit

- To ensure adequate staffing, the facility utilized the draft procedure.

Corrective Actions for 2022 – Central Region

Lunenburg Correctional Center

- No upgrades or corrections were necessary during this time.
- Roster management and constant recruitment efforts were used to assist with staff shortages.

Nottoway Correctional Center, Nottoway Work Center

- New cameras are being installed throughout the facility at Nottoway Correctional Center, transitioning from RapidEye to MaxPro.
- The camera project at Nottoway Work Center has already been completed.
- To assist with staff shortages, assistance was provided by trained non-security staff as well as staff from other facilities.

Corrective Actions for 2022 – Central Region

Rustburg Correctional Unit

- No upgrades or corrections were necessary during this time at the facility.

Stafford Community Corrections Alternative Program

- No upgrades or corrections were necessary during this time at the facility.

State Farm Correctional Center

- No upgrades or changes were necessary at the facility during this time.
- Larger, permanent PREA #55 signs were painted in the housing units.
- To assist with staff shortages, trained non-security staff and drafted employees were used to ensure coverage of critical posts.

Corrective Actions for 2022 – Central Region

State Farm Work Center

- There were no upgrades; however, numerous cameras have been requested.
- To ensure adequate coverage, assistance has been provided from staff at Virginia Correctional Center for Women.
- PREA information and training was provided on an ongoing basis through department meetings and muster.

Virginia Correctional Center for Women

- There were no upgrades; however, numerous additional cameras have been requested.
- PREA information and training was provided on an ongoing basis through department meetings and muster.

Corrective Actions for 2022 – Eastern Region

Brunswick Community Corrections Alternative Program

- Additional cameras were installed.
- Additional mirrors were added.
- Swinging toilet and shower doors were installed.
- Tint was added to the window in the holding cell door to allow adequate toilet privacy.

Caroline Correctional Unit

- No upgrades or corrections were necessary during this time at the facility.

Corrective Actions for 2022 – *Eastern Region*

Deerfield Main Compound and Work Centers

- The cameras at Deerfield Men's Work Center were upgraded. The project, which began in 2021, was completed in 2022 with a total of 152 cameras installed at Deerfield Work Center #1, and 19 cameras were installed at Deerfield Work Center #2.

Greenville Correctional Center

- Additional cameras have been requested.
- Five mirrors were installed in the SORT area.
- Staffing assistance from the Western Region was provided during staff shortage to ensure adequate staffing.

Corrective Actions for 2022 – *Eastern Region*

Haynesville Correctional Center

- To reduce blind spots, a mirror was installed in staff dining.

Haynesville Correctional Unit

- Cameras were installed throughout the facility and in the administration building.
- Mirrors were added in the kitchen preparation and kitchen tool room to reduce blind spots.

Corrective Actions for 2022 – Eastern Region

Indian Creek Correctional Center

- The camera system was upgraded with a total of 152 cameras installed.
- Additional mirrors were added in the kitchen area and throughout the compound.

Lawrenceville Correctional Center

- PVC piping throughout the facility was replaced, to include the PVC piping used as shower curtain rods.

St. Brides Correctional Center

- The camera system, upgrading to high resolution cameras, is ongoing.
- Staff assistance from trained non-security staff and probation officers facilities provided temporary assistance during staff shortage to ensure adequate staffing.

Corrective Actions for 2022 – *Eastern Region*

Sussex I State Prison

- Mirrors were added in the DCE and VCE classrooms, computer lab, grievance office, kitchen, and in inmate dining.
- Additional cameras were installed.
- The slot openings in the inmate shower doors were welded together to ensure adequate privacy.
- To assist with staff shortages, assistance was provided by trained non-security staff as well as staff from other facilities.

Corrective Actions for 2022 – *Eastern Region*

Sussex II State Prison

- Cameras are being upgraded with the renovation project.
- Additional mirrors were added throughout the facility.
- The slot openings in the inmate shower doors were welded together to ensure adequate privacy.
- To assist with staff shortages, assistance was provided by trained non-security staff as well as staff from other facilities.

Corrective Actions for 2022 – *Western Region*

Bland Correctional Center

- A mirror was added in the dry storage room to eliminate a blind spot.
- Adjustments and alterations were made to inmate restroom doors in the dormitories to ensure adequate privacy is provided.

Cold Springs Community Corrections Alternative Program

- No upgrades or changes were necessary during this time at the facility.

Corrective Actions for 2022 – *Western Region*

Cold Springs Correctional Unit

- All volunteers and VDOT workers were provided with refresher PREA training.

Green Rock Correctional Center

- Shower partitions in the housing units were adjusted to allow inmate privacy while maintaining proper security.
- A substantiated sexual harassment investigation resulted in the implementation of additional security measures during inmate movement.

Corrective Actions for 2022 – *Western Region*

Harrisonburg Community Corrections Alternative Program

- A partition was added to one toilet in each dorm for additional privacy.

Keen Mountain Correctional Center

- A mirror was added in the kitchen.
- One substantiated investigation for staff fraternization resulted in the staff being terminated.

Corrective Actions for 2022 – *Western Region*

Marion Correctional Treatment Center

- A mirror was added in the Medical Department.

Patrick Henry Correctional Center

- There were no upgrades or corrective action at the facility during this time.

Pocahontas State Correctional Center

- Cameras were added in the front search area and in the administrative support building.
- Mirrors were added in the kitchen dry storage area and in the library.

Corrective Actions for 2022 – *Western Region*

Red Onion State Prison

- Security supervisors began using body cameras.
- Adjustments were made to the swinging shower doors in C and D building to ensure adequate privacy.
- A substantiated sexual abuse inmate-on-inmate investigation resulted in the perpetrator receiving an institutional charge.

River North Correctional Center

- Mirrors were added in vocational classroom, laundry storage area, and kitchen.

Corrective Actions for 2022 – *Western Region*

Wallens Ridge State Prison

- Security supervisors began using body cameras.
- Swinging shower doors were added in C-Building.
- Mirrors were added in the custodial maintenance shop, kitchen, and laundry areas.

Wise Correctional Unit

- Privacy barriers were added to dorm restrooms to ensure adequate privacy.

Summary

- A total of 786 allegations were reported and investigated during 2022. This compared to 761 allegations during 2021 and 692 allegations during 2020.
- A total of 9 PREA Audits were successfully completed in the calendar year 2022, with all facilities found to be 100% fully compliant.
