Introduction

One of the most revealing ways a correctional agency can assess its success is by measuring recidivism. The Virginia Department of Corrections (VADOC) has been doing this for years by calculating the threeyear re-incarceration rate of its State Responsible (SR) inmates released from a term of incarceration. Virginia has the second lowest three-year re-incarceration rate among SR inmate releases with a rate of 23.9% among inmates released during FY2016.

Measuring re-incarceration of SR Releases only tells part of the story. Not all supervisees entrusted to VADOC's care experience incarceration. In fact, only 35.1% of the community starters analyzed in this study were released from SR incarceration in FY2016¹. This means that the success or failure of supervisees cannot be assessed through the re-incarceration rate of SR Releases alone.

Measuring the recidivism of supervisees on community supervision is crucial in following VADOC's mission. After all, VADOC's work doesn't end upon an inmate's release from prison. In order to "enhance the quality of life in the Commonwealth by improving public safety," the VADOC needs to understand the level of success its supervisees in the community experience after receiving re-entry programming and services.

This report aims to explore the outcomes of community supervision, detailing the characteristics of the supervisees as well as those who become incarcerated during the three years following their supervision start date.

Methodology

This project tracks the recidivism of supervisees who started community supervision with VADOC during FY2016. FY2016 was chosen as the year to analyze because it is the most recent year for which a three-year follow-up is available with mature data².

A "community start" occurs when a supervisee transfers³ to a P&P district from a location that is not a P&P district⁴. In order to be considered a valid community start for the purposes of this project, the supervisee must have stayed at his/her starting P&P district location for more than two weeks (14 days)⁵, must have spent more time being supervised in a P&P district than on interstate compact supervision during the study period, and must not have served a sentence from another state⁶. Because a supervisee may have had multiple community stays that exceeded two weeks during FY2016, this study analyzes the supervisee's first community start with a stay of more than two weeks.

Because supervisees frequently move between P&P districts while on community supervision, supervisees in this study are classified by the P&P district where they were supervised for the **longest time** between their community start date and their three-year follow-up date (New Court Commitment Date [NCC Date] or parole revocation date if they recidivate).

Although Administrative P&P⁷ is not considered a P&P district in this study, supervisees are included in the Administrative P&P section of the report if that is a location where they spent the most time between their community start date and their three-year follow-up date (if they recidivated, their NCC date or parole revocation date). These supervisees are included in this report because they had a supervision obligation.

Supervisees are included in the Voice Verification Biometrics Unit (VVBU) section of the report because most of their time in the community was overseen by the VVBU, which primarily serves low-risk supervisees on community supervision. VVBU began its operations in September 2015.

A supervisee is considered a recidivist if he/she is sentenced to a term of state responsible incarceration⁸ within three years following his/her community start date, even if he/she is no longer on community supervision at the time of the recidivating offense. A supervisee is not considered a recidivist if he/she is not sentenced to a term of state responsible incarceration.

³ The supervisee must have transferred from a location other than a P&P district to a P&P district for a reason other than investigation.

⁴ Locations that are not P&P districts include: local jails, VADOC facilities, Community Corrections Alternative Programs (CCAPs), Administrative P&P, Community Sex Offender Programs, Interstate Compact Community Supervision, Fugitive Unit, Detainer Unit, and Pre-release Unit. For this project, CCAPs are not considered community supervision locations because supervisees confined in these facilities are unlikely to have the same opportunities to recidivate as supervisees reporting to a P&P district.

⁵ The two week community stay requirement was added in order to exclude supervisees who present for supervision, but upon investigation, do not have a supervision obligation with VADOC.

⁶ 252 supervisees were removed due to spending more time supervised on interstate compact supervision than in a P&P district during the study period. 651 supervisees were removed due to serving an out of state sentence in a P&P district. Removing these supervisees produces a recidivism rate of 20.6% compared to a rate of 20.1% if they were left in the analysis.

⁷ Administrative P&P supervisees are those who are unavailable to be actively supervised by a district, generally for at least a six-month period. These supervisees may include absconders, supervisees with long hospital stays, or other supervisees who may be unavailable for active supervision.

⁸ Thirty-two supervisees from the community starters studied had an SR parole violation within three years following their community start date. Twenty were new crime parole violators and twelve were technical parole violators.

Definitions of Key Terms & Measures

Age on FY2016 Community Start Date^{*+} – The age of the supervisee on the date he/she began community supervision at a P&P district during FY2016.

COMPAS (Correctional Offender Management Profiling for Alternative Sanctions) – This represents the system of risk/needs assessments developed by Equivant in its Northpointe Suite. These assessments focus on dynamic risk factors that are known to affect recidivism, and are designed to aid in correctional intervention to decrease the likelihood of recidivism⁹.

COMPAS Recidivism Risk Level*⁺ – This represents the predictor of a supervisee's likelihood to recidivate based on his/her specific criminogenic needs.

Criminal History*⁺ – The number of SR incarcerations that a supervisee had before his/her community start date.

DOC Crime Type* – Indicates the crime type of the supervisee's most serious offense for which he/she is currently on supervision. Includes the categories Violent, Property/Public Order (PPO), Drug, and Not Reported.

History of Positive Drug Tests for Multiple Drugs (Both Opioids and Cocaine)*+ – The existence of at least one positive drug test result for Opioids and/or Cocaine in the time before their community start, until their recidivating date, or within three years post community start. Drug tests for alcohol were not analyzed.

History of Positive Drug Tests for Methamphetamine⁺ – The existence of a positive drug test result for Methamphetamine in the time before their community start, until their recidivating date, or within three years post community start. Drug tests for alcohol were not analyzed.

Gender*⁺ – The gender of the supervisee as recorded in Virginia CORIS.

Major Metropolitan Area – For a district to be considered part of a "Major Metropolitan Area," it must comprise one or more localities that are part of any of the following three metropolitan statistical areas, as defined by the U.S. Census Bureau:

- **Richmond, VA** (includes the cities of Colonial Heights, Hopewell, Petersburg, and Richmond and the counties of Amelia, Caroline, Charles City, Chesterfield, Dinwiddie, Goochland, Hanover, Henrico, King William, New Kent, Powhatan, Prince George, and Sussex)
- Virginia Beach-Norfolk-Newport News, VA-NC (includes the cities of Chesapeake, Hampton, Newport News, Norfolk, Poquoson, Portsmouth, Suffolk, Virginia Beach, and Williamsburg and the counties of Gloucester, Isle of Wight, James City, Mathews, and York)

 Washington-Arlington-Alexandria, DC-VA-MD-WV (includes the cities of Alexandria, Fairfax, Falls Church, Fredericksburg, Manassas, and Manassas Park and the counties of Arlington, Clarke, Culpeper, Fairfax, Fauquier, Loudoun, Prince William, Rappahannock, Spotsylvania, Stafford, and Warren)

In this analysis, Major Metropolitan Area is measured as the P&P district location in which a supervisee spent the most time between his/her community start date and either 1) the three-years following the community start date if the supervisee did not recidivate or 2) the New Court Commitment Date (NCC Date) or parole revocation date if the supervisee did recidivate.

State Responsible (SR) – The SR definition has changed over time and is dependent on several factors: date of offense, offense type (felony or misdemeanor), sentence length and how the sentence is expressed (i.e., years, months, days, or some combination thereof). Any inmate who meets one of the SR criteria below is considered State Responsible.

Supervision Assignment Level* – This indicates the level at which the supervisee is supervised, as assigned by the supervising officer. In this analysis, Supervision Assignment Level is measured as the longest approved level of supervision held by a supervisee for the period studied.

Characteristics and Results

The following pages with green headings show the characteristics of the community starters during FY2016, arranged by the community location where they were supervised the longest during the study period.

Pages with italicized orange headings show the characteristics of the recidivating supervisees —those who have an NCC date or a parole revocation date within three years following their start on community supervision during FY2016.

Regression analysis shows that, when all other factors are kept constant, certain factors are statistically significant predictors of a recidivating supervisee on community supervision¹⁰. These factors include the following:

- Males were more likely to recidivate than females.
- Supervisees who started community supervision at a younger age were more likely to recidivate than those who started at an older age.
- Supervisees who had more SR terms of incarceration prior to their community start date were more likely to recidivate than those who had fewer SR terms of incarceration.
- Supervisees with a higher COMPAS recidivism risk level were more likely to recidivate than those with a lower COMPAS risk level.
- Supervisees who tested positive for both opioids and cocaine were more likely to recidivate than those who did not test positive for opioids and/or cocaine.
- Supervisees who tested positive for methamphetamines were more likely to recidivate than those who did not test positive for methamphetamines.

¹⁰ Determined using a logistical regression model controlling for gender, age at community start, number of previous SR incarcerations, COMPAS recidivism risk level, and testing positive for opioids and cocaine, and methamphetamines prior to their 3-year follow up date. The factors identified as predictors were all significant at p<.0001.



Time to Recidivate in Days by Characteristics

Just as recidivism rates vary among supervisees with different offense types and risk characteristics, the time to recidivate also varies. This report shows recidivism rates and time to recidivism by demographics, substance abuse history, criminal history, supervision level, and COMPAS recidivism risk level of the supervisees. The tables below show the number of days from the start of community supervision to the recidivated date among FY2016 community starters that recidivated and the percent of supervisees who recidivated. For each category, four quartiles and the average time to recidivate are displayed. For example, of the 5,077 males who recidivated, 25% had an SR incarceration within 323 days, half had an SR incarceration within 553 days, 75% had an SR incarceration within 787 days and all were within 1,095 days. On average, male recidivists had an SR incarceration within 556 days. Of all males who started community supervision in FY2016, 22.6% had an SR incarceration within three years.

Demographic factors such as gender, race, and age have been found to be predictors of recidivism. Even though males are more likely to recidivate, they spent longer on average in the community prior to recidivating than female supervisees (556 and 525 days, respectively). The same pattern is seen with age of the supervisee at community start; younger supervisees are more likely to recidivate but spent more time in the community prior to recidivating than older supervisees. Black supervisees spent, on average, 12 more days in the community before starting an SR incarceration term than white supervisees (558 and 546 days, respectively).

Drug use has also been found to be associated with recidivism. Supervisees who tested negative for opioids and cocaine spent, on average, 10 to 42 fewer days in the community before having an SR incarceration than supervisees who had tested positive for opioids and/or cocaine (546 and 556-588 days, respectively). Supervisees who test positive for drugs may receive treatment while in the community, which could contribute to the difference in time to recidivate between those who test positive and those who test negative.

Criminal history is also a known factor in predicting recidivism. Supervisees who had two or more prior SR terms of incarceration spent less time in the community before starting an SR incarceration term than supervisees with one or no history of SR incarcerations. Supervisees whose most serious offense was drugs spent, on average, 39 more days in the community than supervisees with violent (581 and 542 days, respectively) or property/public order crime types (581 and 542 days, respectively).

The COMPAS risk and needs assessment tool is used by the VADOC to determine risk of general recidivism. Supervisees who were classified as high risk on the general risk of recidivism scale spent slightly more time in the community before starting an SR incarceration term than supervisees who were classified as low risk, but less time than supervisees who were classified as medium risk. Of the supervisees who had a supervision level, supervises who were supervised at a high level spent, on average, 7 fewer days in the community than supervisees supervised at a low level (580 and 587 days, respectively). Supervisees who were supervised at an elevated level, on average, spent the least amount of time in the community before starting an SR incarceration (526 days).

Summary and Conclusions

The analyses conducted as part of this report showcase the risk factors that continue to play a statistically significant role in the prediction of recidivism in the FY2016 Community Starters population. There was a 1.1% decrease in recidivism rate for theFY2016 group compared to the FY2015 group. Historically, gender, age, number of SR incarcerations, higher COMPAS risk level, and Opioid and Cocaine use have all been factors that contribute to a higher likelihood of recidivating. In the FY2016 group, these contributing factors persisted. Community starters that were male, younger, had more SR incarcerations, had a higher COMPAS risk level, and/or had a history of both Opioids and Cocaine (before and after community start) were more likely to recidivate within the three year follow-up period. However, history of Methamphetamine use prior to or after their community start date was also a significant contributor to recidivism risk (38.1%) among those who tested positive.
