



Veterans in VADOC Populations as of June 30, 2026

VADOC Research Unit

August 2026

This report details information on veterans who were either: 1) inmates in the Total State Responsible (SR) Confined Population or 2) on community corrections supervision with the Virginia Department of Corrections (VADOC) on June 30, 2026.

Veterans by Location

Veterans comprised less than eight percent of the various VADOC populations, but there were slight differences between location types. Among the Total SR Confined Population at the end of June 2026, veterans made up 7.8% of the SR population in VADOC facilities and 4.6% of the SR population in local/regional jails. Among the VADOC Community Correction Population, veterans comprised 6.2% of the population supervised in VADOC Probation and Parole (P&P) Districts and 5.3% of participants in the Community Corrections Alternative Program (CCAP).

Of the 1,771 veterans incarcerated in VADOC facilities, almost one-half (48%) had a conviction for a Category A sex offense.¹ More than one-quarter (26%) of the 152 veterans incarcerated in local/regional jails had such a conviction. Among the 3,634 veterans supervised in P&P Districts, almost one-fifth (19%) had a conviction for a Category A sex offense. Two (8%) of the 25 veteran CCAP participants had such a conviction.²

While inmate veterans in the Total SR Confined Population were incarcerated in VADOC facilities throughout the state, they were predominantly in facilities in the Eastern and Central Regions (45% and 32%, respectively). Sixteen percent of inmate veterans were incarcerated in facilities in the Western Region and 8% were incarcerated in local/regional jails. More detailed information by location is shown in Table B on the next page.

Veterans on community corrections supervision were predominantly supervised by P&P Districts in the Eastern Region (29%), while 24% were supervised by Districts in the Western Region and 23% were supervised by Districts in the Central Region. Another 19% were supervised by the centralized Voice Verification Biometric Unit (VVBU). More detailed information by location is shown in Table C on Page 3.

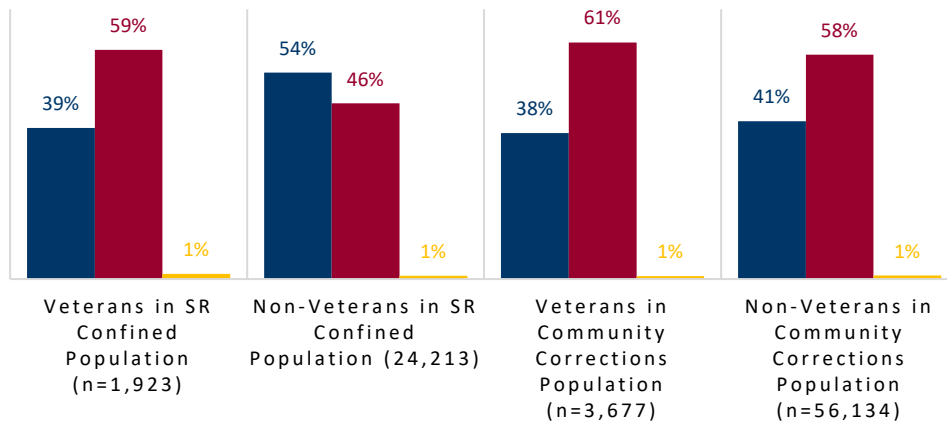

Veteran Inmates and Supervisees by Race and Most Serious Offense

The racial composition of non-veteran inmates in the Total SR Confined Population was 54% Black and 46% White. Conversely, the racial composition of the veteran population was 39% Black and 59% White. However, the racial composition of the Total Community Corrections Population was similar regardless of veteran status:

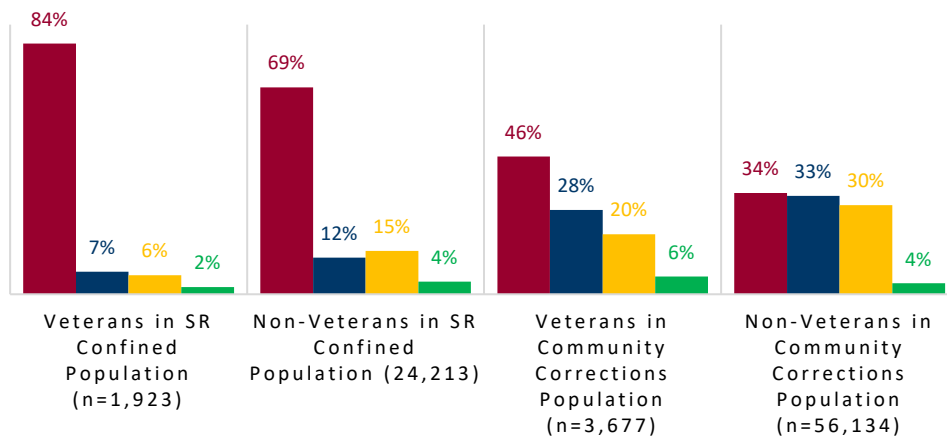
- Veterans (38% Black; 61% White)
- Non-Veterans (41% Black; 58% White)

Eighty-four percent of veterans in the SR Confined Population had a Violent MSO compared to 69% of inmates who were not veterans. More than one-quarter of the non-veterans had either a Property/Public Order (PPO) MSO (12%) or a Drug MSO (15%). These percentages were 7% and 6% for the veterans.

Fewer than one-half of the veterans on community corrections supervision (46%) had a Violent MSO while more than one-third of the non-veterans on supervision (34%) had such an offense. More than one-quarter of the veterans (28%) had a PPO MSO and one-fifth had a Drug MSO. Among the non-veterans, one-third had a PPO MSO while 30% had a Drug MSO.
