# 2025: A Year in Review

### Calendar Year 2025

The Virginia Department of Corrections (VADOC) Victim Services Unit (VSU) is committed to enhancing public safety by providing information, notification, support, and trauma-informed assistance to victims of crime whose perpetrators are under the custody or supervision of the VADOC. The VSU supports evidence-based perpetrator programming to identify the impact of their crimes on victims and communities. In addition to notification, the Victim Offender Dialogue program provides victims with a voice and aids in the healing process.

# CY2025 was another busy year for the Victim Services Unit.

Direct services were provided to more than 3,200 crime victims, VSU staff made presentations across the state and at national trainings and conferences, and the NAAVI system sent thousands of automated notifications. We continued another successful year with the Victim Offender Dialogue (VOD) Program, the Victim Impact Program (VIP), and the Crime Victim Speakers Bureau, moving our programming toward a vision of prevention, awareness, and healing. VSU staff completed 147 site visits to VADOC sites, and an additional 117 site visits to local Victim/Witness Assistance Programs, our close professional allies in the victim advocacy sphere. Staff also participated in local, state, and national coalitions, and our commemoration of National Crime Victims' Rights Week brought awareness to the rights and needs of crime victims across the Commonwealth.

## 2025 HIGHLIGHTS

- \* Direct services provided to more than **3,200 crime victims**
- \* Victim Impact Program: **27 active VADOC sites** with **550 program completions** at facilities, CCAPs, and districts, an increase of 86% from 2024
- \* More than **13,000 automated notifications** sent via the NAAVI system
- \* **2 VOD cases** completed and 4 cases in preparation
- \* **Over \$4,200** provided in travel reimbursement for Speakers Bureau volunteers

## About the VSU

The Virginia Department of Corrections (VADOC) is committed to supporting the rights and needs of victims of VADOC inmates and supervisees. Consistent with its mission and Virginia's Crime Victims' Bill of Rights, the VADOC strives to keep crime victims informed and involved during the post-sentencing phase of Virginia's justice system. Victims and survivors, their families, and communities are supported by the department in the aftermath of crime. The Victim Services Unit (VSU) supports evidence-based programming through which participants have the opportunity to learn about empathy and take accountability for their actions in order to better understand the impact of their crimes on victims and communities.



# Victim Services Unit Staff

The VSU office is located at VADOC Headquarters in Richmond, VA and falls under the Division of Programs, Education, and Re-entry. The unit is funded by a combination of agency and Victim of Crime Act (VOCA) grant funds through the DCJS Victim/Witness Grant Program (VWGP).

Volunteers additionally provide critical support, both in the form of crime victim guest speakers sharing their stories for the Victim Impact Program and other trainings and events, and VADOC staff volunteering their time as VOD facilitators.





## Victim Offender Dialogue (VOD)

The Virginia Department of Corrections provides a facilitated Victim Offender Dialogue (VOD) process. This process is victim-initiated and inmate sensitive. After a series of preparation meetings with a trained facilitator, a face-to-face dialogue may occur between the victim/survivor and the perpetrator responsible for the crime.

In 2025, two staff completed VOD training at the National Institute of Corrections in Aurora, CO. One staff member was a guest trainer for NIC.

## Unwanted Contact

When an inmate reaches out or attempts to reach out to a member of the general public, including their crime victims or those they have threatened in the past, it can be devastating. The 136B institutional charge was added to Policy 861.1 in 2017 to address growing occurrences statewide. This institutional charge holds inmates accountable for contact that is threatening and/or contact that violates a court order. Further collaboration with localities and VADOC's Office of Law Enforcement Services (OLES) ensures that inmates are held accountable and further contact is prevented.

**In 2025, VSU wrote 26 institutional charges to hold inmates accountable for threatening and/or prohibited contact.**

# Victim Registrations, Notifications & Services

The VADOC Victim Services Unit serves as a guide for victims during the post-sentencing phase of the Virginia criminal justice system, providing information about intake, classification, time calculation, and release planning. Victims also receive assistance and information about the re-entry plan, including safety planning, service referrals, and assistance with the transition to community corrections.



## Victim/Client Surveys

- **97%** of 2025 survey respondents agreed that the NAAVI system “Always” keeps them informed.

- **93%** of 2025 survey respondents reported at least one positive outcome after working with a VADOC advocate:

# Automated Victim Notifications in CY2025



Since October 2021, NAAVI (Notification And Assistance for Victim Inclusion) has provided automated notifications to crime victims while their perpetrator is in VADOC custody. To receive automated notifications, victims must register with the system. This also provides them with access to and notifications from the Virginia Parole Board and the Virginia Office of the Attorney General.

# Victim Impact Program



This education/awareness curriculum is focused on sensitizing participants to the impact that crime has on victims, families, and the community. The program is structured to encourage accountability and to foster a level of empathy toward crime victims and survivors. The goal of this program is to have inmates and supervisees increase their insight into the harm they have caused their victims and the ripple effect of that harm throughout the community. VIP is a 13-week program with each session lasting approximately 2.5 hours. Each subsection of offenses covered in the curriculum focuses on the financial, physical, emotional, and religious/spiritual impacts of crime. The program also incorporates the use of victim speakers. The photos displayed above capture moments from awareness activities conducted at Cold Springs CCAP and Baskerville Correctional Center.

# Crime Victim Speakers Bureau

VSU strives to include victim and survivor voices in the correctional process, especially as a part of the Victim Impact: Listen and Learn program. Speaking can empower victims and give voice to their experiences. It also aids inmates and supervisees in understanding the true impact and “ripple effect” of their crimes on victims, survivors, and the community. Guest speakers can also assist staff in understanding an important perspective of crime and criminal justice.

## 2025 By the Numbers

**14 active speakers**

**44 Victim Speaker presentations** at Victim Impact classes, trainings, and conferences

**269 volunteer hours** given to VADOC by Speakers Bureau members reaching an audience of over **500 inmates/supervisees** and more than **175 staff**, traveling more than **5,200 miles** across the Commonwealth to share their stories

**\$4,297.53** in travel reimbursement provided to Speakers Bureau members

## Highlight: Celebrating Voices of Impact Luncheon

On August 12, 2025, ten members of the VADOC's Crime Victim Speakers' Bureau were honored at a reception, held at the Academy for Staff Development - Crozier. VADOC Senior Leadership was in attendance, along with the staff of the Victim Services Unit, to show appreciation for the time and energy given by these inspiring volunteers. In sharing their stories, they are not only offering insight into the real, human consequences of crime, but offering something more— an opportunity for reflection, for accountability, and, ultimately, for change. These ten speakers have spoken to more than 2,500 VADOC staff, inmates, and supervisees since the Bureau's inception in 2017, traveling more than 35,000 cumulative miles across the Commonwealth, and they have given nearly 1,000 cumulative volunteer hours to the agency.



Gifts for the speakers included brick planters from the masonry class at Appalachian CCAP and plants from the horticulture programs at Greenville Correctional Center and State Farm Correctional Center.

## Highlight: Unsung Hero Award

VADOC Guest Speaker Paige Meade is honored by the Virginia Office of the Attorney General

Paige, a VADOC volunteer guest speaker, is the embodiment of an unsung hero—someone who has turned her personal trauma into a lifelong mission of service, advocacy, and healing for sexual assault survivors. During National Crime Victims' Rights Week in April 2025, Virginia Attorney General Jason Miyares honored Paige and eighteen other individuals, all of whom work tirelessly to serve and empower crime victims across the Commonwealth. She was nominated by the VADOC Victim Services Unit for her work with the Victim Impact Program, along with advocacy and service she provides in her Northern Virginia community.



## Additional Highlights

- Members of the Victim Services Unit were invited to participate in a legislative workgroup for HB2252, which seeks to codify the process for early discharge from supervision. VSU staff were able to ensure that the rights and needs of crime victims were given consideration.
- A member of the Victim Services Unit was asked to be part of an advisory committee with a local community college that is building a victim advocacy career training certificate
- Hundreds of inmates and probationers participated in topic seminars to raise awareness of the impact of Drunk and Impaired Driving. Locations included Appalachian CCAP, Brunswick CCAP, Chesterfield Women's CCAP, Cold Springs CCAP, Cold Springs Correctional Unit, Green Rock Correctional Center, Greensville Correctional Center, Indian Creek Correctional Center, and Pocahontas State Correctional Center. Feedback from participants and staff was overwhelmingly positive, with comments such as:

*"This is the best session I have taken part in. It really made me dig deeper into the effects of my choices on others."*

*"[Victim] is an incredibly strong person. After what has happened to them—learning to walk again, etc.—I just can't imagine being able to accomplish what they did."*

*"Their story is so uplifting. I don't know if I could be that way after such loss."*

*"I am here for this crime. I understand better now what my choice did to my victim."*



# National Crime Victims' Rights Week






# Advocate Credentialing


